We are excited to host the 2017 Ann Arbor Farmers Market Food Truck Rally season. These events will take place on the first Wednesday of the month, 5p.m.- 8p.m, May through October. We are proud to continue these wonderful, well-attended community events and hope you will consider participating. We welcome food carts, trucks, and ready-to-eat food options from local restaurants and specialty food businesses.

In addition to hosting tasty meal options at the 2017 First Wednesday Food Truck Rallies, we invite our regular farmers market vendors to participate as well. Product lists for these events are subject to approval, as not all items will be a good fit for these specific events.

Application Details

The Ann Arbor Farmers Market is a producers-only market, meaning all items offered for sale must be of the vendor's own producing. No supplemental items, such as bottled beverages or chips, may be offered unless you make those items yourself.

Applications must be received by March 20, 2017. Following the March 20 deadline, additional vendor applications will be evaluated based on the market's product mix and available space.

Event Dates & Information

First Wednesday Food Truck Rallies will run 5:00 – 8:00 pm. Vendors are expected to arrive on site between 4pm and 4:30 p.m. in order to ensure adequate time to setup and unload. Vendors will be permitted to stay on site until 9p.m. for sales and clean up. Daytime vendors wishing to stay for the event will be permitted to leave necessary stall equipment on site between the end of the market and the start of the rally.

Payment

Please **do not** send payment with your application. Payment forms will be sent upon approval of your application.

In order to receive full promotion of your business for the event (posters, social media, press), full season payment must be made. Vendors wishing to pay per event must confirm their attendance 2 weeks prior to the event in order to be included in promotional materials. Any vendor who cancels after confirming their attendance for an upcoming event will still be held responsible for the event fee regardless of absence.
