FEES AND BONDS REQUIRED

AN ORDINANCE TO AMEND SECTION 7:33 OF CHAPTER 77 (FEES AND BONDS REQUIRED) OF TITLE VII OF THE CODE OF THE CITY OF ANN ARBOR

The City of Ann Arbor Ordains:

Section 1. That Section 7:33 of Chapter 77 of Title VII of the Code of the City of Ann Arbor be amended to read as follows:

**7:33. Licenses for: (A-D).**

Alarm connections:

Annual fee (alarm connection Permit) . . . \$36.00

Annual fee (per auto dialer Telephone number) . . . 120.00

Annual fee (per monitor Board) . . . 120.00

City Council may by resolution periodically establish such alternate fee schedule as it deems necessary or appropriate for the provision of alarm-related services.

Alarm systems license:

Annual fee . . . 25.00

Insurance

Personal injury (person) . . . 200,000.00

Personal injuries (1 accident) . . . 400,000.00

Property damage (1 accident) . . . 100,000.00

City Council may by resolution periodically establish such alternate fee schedule and/or insurance limits as it deems necessary or appropriate for the provision of alarm-related services.
