



**APPROVED MINUTES OF THE REGULAR SESSION OF THE
HISTORIC DISTRICT COMMISSION OF THE CITY OF ANN ARBOR
Thursday, December 10, 2009.**

A - HEARINGS

A-1 HDC09-163 – 100 ARBANA DRIVE - OWSHD

BACKGROUND: This is a modern building and a non-contributing structure in the Old West Side Historic District.

LOCATION: Northeast corner of Arbana Drive and Huron Street.

APPLICATION: The applicant seeks HDC approval to install a new 8 foot by 3 foot business sign on a brick base that is 9 feet by 1 ½ feet. The sign would be externally lit by two strips of LED lighting, one on each face, and would be located on West Huron.

STAFF FINDINGS:

1. The sign panel is proposed to be to have two faces, each with space for changeable text. The changeable text would be located behind a clear, locking vandal cover which prevents the removal or rearrangement of the text. The sign would be lit on the top edge of each side with a strip of LED's that are shielded by the sign casing. Many of the church's activities are in the evening, so the applicant feels that lighting is necessary. The brick base would be a shade of tan that is compatible with the building.
2. The proposed sign is compatible in exterior design, arrangement, texture, material and relationship to the remainder of the building and surrounding area and meets *The Secretary of the Interior's Standards for Rehabilitation*, in particular standards 2 and 9.
