

Water, Sewer & Stormwater Rates

Effective July 1 2008 Ann Arbor water bills will be charged according to the following rate structure, based on water meter readings.

Notes to the above chart:

***1 CCF = 100 cubic feet = 748 gallons = a standard measurement for water.**

****Water Only meters** are allowed only for water uses that do not result in return flow to the sanitary sewers, e.g., into a drain, and typically used for landscape irrigation or cooling tower operations.

- **The majority of water bills are measured and mailed on a quarterly basis.** A few water accounts are billed monthly and are pro-rated according to the quarterly charts, listed above.

- Residential locations with an additional Water Only** meter are billed according to the Residential 2 chart for their standard water meter, and charged from the Water Only chart for the water used through the second meter.
- Businesses are billed according to the Commercial rate chart and the Water Only chart, if applicable, for operating a second Water Only** meter.

+Stormwater Charge Rates

Stormwater rates are assessed based on the amount of impervious area—or hard surfaces such as roofs, driveways, patios—on the property. Individual property stormwater assessments are available online at www.a2gov.org/storm.

Single and two family residential properties are grouped into one of four tiers. The average percentage impervious square feet area for that tier is then used to calculate their quarterly storm water discharge fee. The impervious area is charged \$309.79/acre.

Tier 1: Less than or equal to 2187 square feet: will be billed for 4% of an impervious acre. (\$12.39)

Tier 2: Greater than 2187 to less than or equal to 4175 square feet will be billed for 7% of an impervious acre. (\$21.69)

Tier 3: Greater than 4175 to less than or equal to 7110 square feet will be billed for 12% of an impervious acre. (\$37.17)

Tier 4: Greater than 7110 square feet will be billed for 21% of an impervious acre. (\$65.06)

- **Allowable Residential Credits** (up to three rate reductions are available per quarter; details are available at www.a2gov.org/storm.
 - **RiverSafe Homes:** \$1.24/parcel.
 - **Rain Barrels:** (one or more): \$1.79/parcel
 - **Rain Gardens/Cisterns/Dry Wells:** \$2.80/parcel
 - **Chapter 63 compliant Stormwater Control:** \$7.16/parcel

Commercial properties will be charged on their impervious area measurement, based on the same rate as the single and two family tiers (\$309.79 per impervious acre per quarter) plus the \$6.77 quarterly customer charge.

- **Allowable Non-Residential Credits** (per quarter):
 - **Community Partners for Clean Streams:** will reduce the customer charge by 17.3%
 - **Chapter 63 Compliant Stormwater Control:** will reduce the stormwater discharge fee by 19.5%.
 - **Other Approved Stormwater Controls:** will reduce the stormwater discharge rate by 6.4% and customer charge by 17.3%
