Plante and Moran conducted an audit of the Maple Tower Limited Dividend Housing Association, Limited Partnership and the River Run Limited Dividend Housing Association, Limited Partnership for FY 2015 (Jan 1, 2015 to December 31, 2015). Plante and Moran found the same two material weaknesses in both of the audits.

The findings were largely the result of the limited experience of AACH staff with LIHTC developments, specifically as it relates to the roles of AAHC as the general partner and Norstar as the developer.

Below are the findings and associated responses from management as they relate to each finding:

Audit Finding	Background	Management Response
<p>1. There was a lack of oversight and monitoring over the combination of the operating and development financial information reported in the trial balances and financial statements. This deficiency resulted in the identification of many adjusting journal entries proposed and recorded by management during the course of our audits and could have resulted in material misstatements of the financial statements. These lack of controls could result in material errors of unrecorded or improper development activity and operation activity. Generally accepted accounting principles require proper accrual accounting of all partnership activity, including development and operation activity, on a timely basis.</p>	<p>For 2015 the AAHC managed all of the operating activities and accounted for these activities in its monthly financial statements to the board. Norstar managed all of the development activities which were not incorporated into the AAHC's financial statements during the fiscal year, which made it difficult to provide that information to the auditor for the audit. As a consequence, the AAHC had to make year-end adjustments incorporating the development activity with the operating activity for the audit.</p>	<p>The developer is sending financial transaction information on an ongoing basis for the remaining development activity. The information is being incorporated into the accounting system for purposes of consolidating both operating and development activities to comply with generally accepted accounting principles. Since the developments were completed during 2016, this will no longer be necessary for future years.</p>

<p>2. There was a lack of oversight and monitoring of the development activity by the general partner. There should be monitoring of the controls and activity occurring with the development activity by the general partner. There was difficulty obtaining audit support, such as year-end bank statements and the related reconciliations on the development trial balances. Additionally, there was a lack of knowledge and monitoring of the controls at the development level.</p>	<p>The AAHC did monitor and approve all development activities through the Facility Manager and the Executive Director who approved the scope of work, monitored construction, conducted inspections, and approved all financial draws by Norstar. All construction draws also had to be approved by Mitchell and Mouat, the project architect, after making a physical inspection to verify the scope of work was completed. All construction draws were also approved by JP Morgan Chase, the construction lender, and Absolute Title before any funds were released. However, the AAHC failed to collect financial statements and bank statements from Norstar to monitor and incorporate the financial information into the AAHC's operating financials during 2015. This lack of oversight is what led to the two audit findings.</p>	<p>Financial documentation – along with reconciliations – are now being received from the developer on an ongoing basis. This documentation is reviewed by AAHC staff on an ongoing basis.</p>
