AKT PEERLESS ENVIRONMENTAL AND ENERGY SERVICES, LLC (AKT Peerless) was retained to perform limited asbestos testing and radon testing at the following complexes in the Ann Arbor Housing Commission system:

- Upper Platt, 3681-3689 Platt Road
- South Seventh, 221-253 South Seventh Street
- Hillside Manor, 1020-1040 Pennsylvania
- Malletts Creek, 2670-2680 S. Main Street
- Oakwood, 3565-3585 Oakwood

Lead-based paint testing was performed at the South Seventh Street complex only.

SUMMARY OF FINDINGS BY COMPLEX AND ASSOCIATED ADDRESS

Upper Platt

- Asbestos No asbestos containing materials (ACM) were identified in the suspect materials tested. Two materials were assumed ACM: roofing and duct vibration cloth.
- Radon

3681 – 0.7 picoCuries/L (pCi/L)
3683 – 4.9 pCi/L (Result was above the EPA Action Level of 4.0 pCl/L)
3685 – 1.3 pCi/L
3687 – Access not provided at the time of site visit
3689 – 1.8 pCi/L. Duplicate Sample – 1.7 pCi/L



South Seventh Street

- Asbestos No asbestos containing materials (ACM) were identified in the suspect materials tested. Roofing material was assumed ACM.
- Radon
 - 221 1.5 (pCi/L). Duplicate was 1.8 pCl/L.
 - 223 7.6 pCi/L (Result was above the EPA Action Level of 4.0 pCl/L)
 - 231 1.2 pCi/L
 - 233 1.4 pCi/L
 - 241 2.2 pCi/L
 - 243 2.9 pCi/L
 - 251 3.0 p/Ci/L
 - 253 3.6 p/Ci/L
- Lead-based Paint No lead based paint was identified in any paint coatings tested. Access was not granted to test 251 South Seventh Street on the date testing was scheduled. Lead paint inspection must still be performed at the 251 South Seventh Street address.

Hillside Manor

- Asbestos No asbestos containing materials (ACM) were identified in the suspect materials tested. Roofing was assumed ACM.
- Radon

1020 – Initial results invalid. Re-test media set on September 9, 2013. 1030 – 1.6 pCi/L

1040 - Initial results invalid. Re-test media set on September 9, 2013.

Mallets Creek

- Asbestos No asbestos containing materials (ACM) were identified in the suspect materials tested. Roofing material was assumed ACM.
- Radon Addresses were not set up by tenants on previously scheduled testing dates. Initial tests were set on September 9th, 2013.

Oakwood

• Asbestos

3565 – Drywall mud tested positive for asbestos. No asbestos containing materials (ACM) were identified in the suspect materials tested. Roofing material was assumed ACM.

3575 – Drywall mud tested positive for asbestos. No asbestos containing materials (ACM) were identified in the suspect materials tested. Roofing material was assumed ACM.

3585 - No asbestos containing materials (ACM) were identified in the suspect materials tested. Roofing material was assumed ACM.



Radon
 3565 – 3.9 pCi/L. Duplicate was 3.9 pCi/L.
 3575 – 2.1 pCi/L
 3585 – 1.3 pCi/L
