West Park Bandshell Engagement Strategy



Background



Spring 2021: Damage to Stucco surface of Bandshell is discovered during internal inspection.

Summer 2021: City hires Hubbell, Roth and Clark (HRC) to do a structural investigation on the Bandshell. Bandshell is fenced off for safety concerns while investigation and report are completed.

Fall 2021: Structural Report is finalized, identifying significant structural failures in the foundation.

Spring / Summer 2022: Grant research, coordination with Michigan Department of Natural Resources

Summer / Fall 2022: Begin conversation with consultants to develop an engagement.

Winter 2022: Begin Community Engagement efforts.

Architects and Engineers. They have helped us
with community engagement recently with the
Gallup Park Bridge and Road project. SmithGroup
will be the prime consultant for community
engagement efforts.

Hubbell, Roth & Clark, Inc.

Parks also has a standing contract with Hubbell, Roth & Clark, Inc. (HRC). HRC is comprised of architects, structural engineers, and civil engineers. They performed the original structural analysis of the Bandshell, and will be supporting SmithGroup with project background, technical expertise, and cost **estimation**.

Working Group

Work group will be formed prior to engagement kicking off. The representatives of this group are still being discussed.

Team will meet throughout the process, including an initial meeting to go through the planning process.

Work Group will be an important piece of the community engagement plan, providing value feedback to the consultant team.

Will provide consistency throughout the process.

Site Analysis + Conceptual Plans

Site Analysis: Smithgroup and HRC will perform a review of important site characteristics to determine opportunities and constraints.

Physical Features: Topography, Soils, Trees, Wetlands, Drainage

Circulation: Vehicular, Pedestrian, Accessibility

Programming: What is happening now? What are future needs?

Conceptual Plans

- Conceptual Plans will be developed based on information that was gathered during the first round of community engagement and the site analysis phase.
- Conceptual plans will be reviewed and discussed with the Working Group
- Cost Estimates will be supplied to provide guardrails, and ensure a feasible outcome.
