We are combining with the Sunday Artisan Market to offer a special Flower Day, which will also include food trucks, live music, backyard beekeeping tips, gardening how-to advice from Master Gardeners, kids activities and tons of fun! Last year the event was well attended, and we hope to draw an even bigger crowd this year. Event will run 10 am – 4 pm.

Eligible products include flowers, plants, herbs, prepared food, artisan products (preferably flower themed, but not required), and misc. Priority will be given to current Ann Arbor Farmers Market vendors, though we are accepting applications from all businesses.

Applications due by May 1st.

Payment is due by May 24th, day of the event.

Stalls for Flower Day will be charged \$25 for first stall/\$10 each additional.

1. The approval of applications is based on the discretion of the Market Manager. The Market Manager has the right to refuse any application.
2. Vendors must arrive by 9am to set up and stay the duration of the event 10am-4pm.
3. Vendors must understand and comply with the Ann Arbor Farmers Market's operating rules, which are found on the market website.
4. You must provide your own table and chairs and any other equipment needed.
5. Stalls will be pre-assigned and market staff will direct you when you arrive. We will do our best to assign you to your preferred stall but there is no guarantee.
