Meeting Notes

Questions or comments from attendees were submitted both by computer and phone audio (live) which were paraphrased or through the Zoom Q&A feature. Answers and responses from staff during the meeting are marked with an 'a'. Clarifications or responses provided after the meeting are denoted as "Post-Meeting Notes."

Overview

An electronic meeting through Zoom was held to provide a brief overview of the Traffic Calming process, to discuss the Starter Idea specific to Manchester Road (Buckingham Road to Needham Road) as well as modifications to the Starter Idea. Refer to the Traffic Calming Guidebook available at a2gov.org/TrafficCalming for additional information on the Traffic Calming process. Considering the Starter Idea shared at Meeting #1, community feedback, street conditions, utility locations, and engineering practices, staff will develop a Preliminary Plan for Meeting #2.

Discussion

- **1.** On-Street Parking: Vehicles are legally parking on Grandview, and it is too close to the intersection, making it unsafe for vehicles turning onto Grandview.
 - a. (Post-Meeting Notes) There are No Parking signs at both ends of Grandview on both sides of the street approximately 50-feet from intersecting roadways. If there are vehicles/delivery trucks parking within this area, Community Standards (a division of the Ann Arbor Police Department) may be contacted to conduct enforcement in the area. Please note, they will only conduct enforcement if they are requested. A report can be filed online or through the A2 Fit It App. You may also reach them at 734-794-6942. The AAPD prefers residents to contact them directly so they can get additional information if necessary.
- **2.** Truck Traffic: Trucks have been observed using Grandview as a pass-thru even though there are No Thru Trucks signs at both ends of the street.
 - **a.** (*Post-Meeting Notes*) The <u>Ann Arbor Police Department</u> will need to be contacted for trucking violations. Reports can be filed at any time at their front desk. You may also reach them (non-emergencies) at 734-794-6920. The AAPD prefers residents to contact them directly so they can get additional information if necessary.






