#### **Meeting Notes**

#### Overview

An electronic meeting through Zoom was held to provide a brief overview of the Traffic Calming process, to discuss the Starter Idea specific to Manchester Road (Buckingham Road to Needham Road) as well as modifications to the Starter Idea. Considering the Starter Idea shared at Meeting #1, community feedback, street conditions, utility locations, and engineering practices, staff will develop a Preliminary Plan for Meeting #2.

#### Discussion

- **1.** Starter Idea: Why were the drive-over options, in the plan presented for feedback, selected compared to other possibilities, for instance elements from the drive-around category?
  - a. (Post-Meeting Notes) Any horizontal devices (things you drive around) used must maintain a minimum clearance of 20 feet per the Ann Arbor Fire Department. Manchester Road averages a 24-foot-width within our project area, ruling out most of the drive-around devices in our guidebook. Curb extensions were not initially considered because they would remove on-street parking, which also can act as a drive-around traffic device by creating the perception of a narrow roadway.






