### Overview

### Discussion

- 1. Preliminary Plan: What trees would be affected/would they be replaced?
  - a. (Post-Meeting Notes) Based on previous field reviews, we believe one or more trees would be impacted by the proposed crosswalk at the S. Forest intersection. We have reached out to the Ann Arbor Forestry Public Works Department to confirm this (as well as the proposed crosswalk at the Olivia intersection) and determine a response is that aligns with the city's forestry guidelines and resident expectations. Additional information will be shared with the release of the Final Plan.




