Division 16050, Page 3, Section 3.2 A

Change second sentence; "... the five Motor Control Centers,..." to "... the four Motor Control Centers,..."

Division 16050, Page 3, Section 3.2 C

Change; "Provide six (4) bound documents..." to "Provide four (4) bound documents..."

### II. QUESTIONS AND ANSWERS

The following Questions have been received by the City. Responses are being provided in accordance with the terms of the ITB.

### Question #1:

The specification 3.2(A) indicates the scope as being "from Unit Substation No. 4 through the five Motor Control Centers". However, the drawings only show four motor control centers. Please clarify which MCC's are to be included.

#### Answer: #1

This was a typo as there are only four MCCs.

### Question #2:

The specification 3.2(A) also indicates an existing study will be provided. Please indicate if this is will be a study report (e.g. a pdf of the existing report) or if the study software model (electronic file used by modeling software) will be provided. If a study model, please indicate for which software.

#### Answer #2:

The existing study to be provided will be a pdf or printout of the existing report.

#### Question #3:

The specification 3.2(C) indicates "Provide six (4) bound documents". Please clarify if six (6) or four (4) copies of the report are to be provided.

#### Answer #3:

Only four (4) bound copies of the document will be required and one (1) copy on a compact disk.

Bidders are responsible for any conclusions that they may draw from the information contained in the Addendum.
