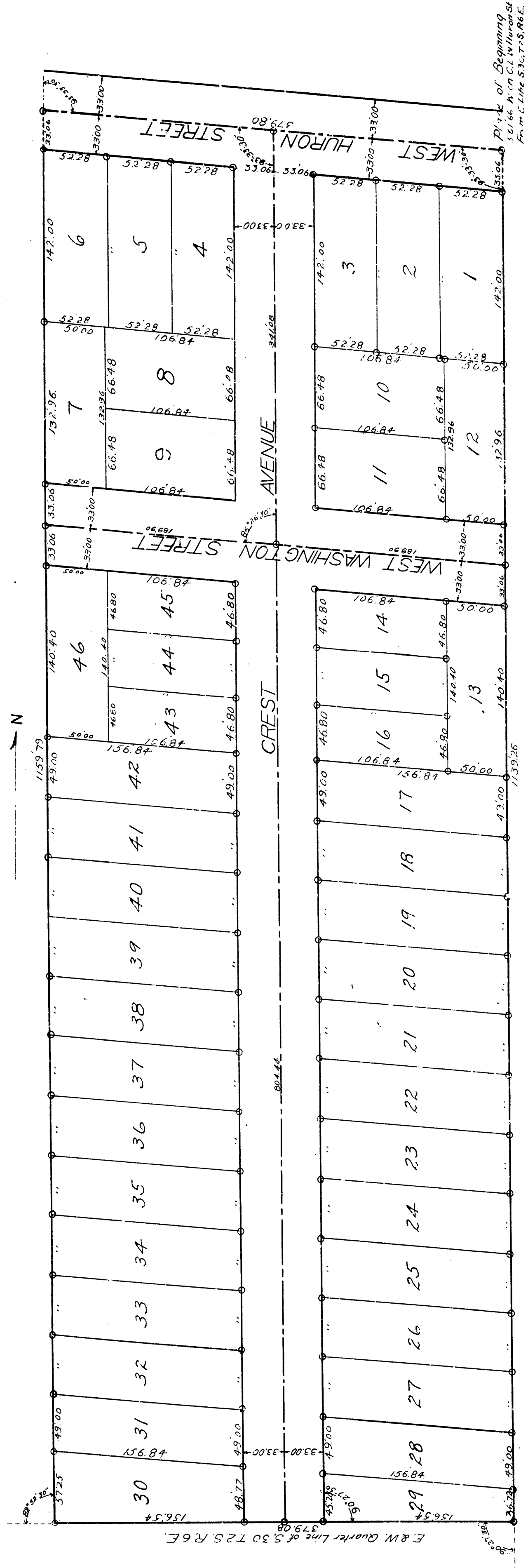


HURON CREST SUBDIVISION IN THE CITY OF ANN ARBOR WASHTENAW COUNTY MICHIGAN

DESCRIPTION OF HURON CREST SUBDIVISION
HURON CREST is described as follows: Beginning at an iron pipe on the center line of West Huron Street 561.66 West of an iron pipe marking the intersection of the East line of Section 30 Town 2 South, Range 6 East and the center line of Huron St. thence deflecting 93° 33' 30" to the left 113.52 to an iron pipe thence deflecting 90° 21' 30" to the right 57.92 to an iron pipe, thence deflecting 93° 33' 30" to the right 159.77 to an iron pipe on the center line of West Huron Street thence deflecting 93° 33' 30" to the right 379.80 along the center line of West Huron St. to the place of beginning. Being a part of the N.E. 1/4 of Sec. 30, T. 2 S. R. 6 E. Meridian of Michigan.
