### **Questions and Answers**

The following Questions have been received by the City. Responses are being provided in accordance with the terms of the RFP.

Question #1: DLZ's bridge inspection report identifies streambed cross-sections under Option 1. This item of work was intended to be completed by the bridge inspector during the bridge inspection cycle scheduled for October 2016 to satisfy MDOT's recommendations. Please confirm that this survey will not be included in the repair scope of work in this RFP.

Answer #1: The survey is included in the scope of work for RFP No. 875 for the purposes of developing a scope of repairs. The Consultant should review and update the channel cross-sections as needed to determine the exact position of the river channel at the location of the bridge and it's pier.

Question #2: DLZ's bridge inspection report identifies obtaining an underwater inspection under Option 1. This item of work was intended to be completed by a MDOT pre-qualified consultant in Underwater Bridge Inspection to satisfy NBIS requirements. An underwater inspection can be obtained by a non-qualified firm for the purposes of developing a repair scope of work. Please confirm that the underwater inspection (investigation) referred to in the RFP is to be done for the purposes of clarify the scope of the repairs and not to satisfy the NBIS underwater bridge inspection requirements.

Answer #2: The underwater inspection (investigation) referred to in the RFP is to be done for the purposes of clarify the scope of the repairs and not to satisfy the NBIS underwater bridge inspection requirements. The underwater inspection shall be performed by an inspector with the appropriate NBI qualifications to perform this work.

Question #3: Please confirm that the plans will be developed using MDOT format, specifications, guides, and pay items.

Answer #3 The plans and specifications should be prepared following MDOT Standards. However, the City of Ann Arbor (PMSU) also has several unique project requirements that we employ. Consequently, the Consultant shall expect that several unique project special provisions shall be authored. The city reserves the

right to review and approve all contract pay items, plan sheet scales and layouts, and project specifications.
