DESCRIPTION

The land embraced in the annexed plat of "BOULEVARD MANOR", part of the southwest quarter section 30, Ann Arbor Township, Washtenaw County, Michigan, is described as follows: Commencing at an iron pipe at the center of section line two south, range six east, Washtenaw County, Michigan; thence WEST along the east and west quarter line of said section 268.22 feet to an iron pipe, said pipe being 268.22 feet east of the southeast corner of the plat of "Jackson Heights Subdivision"; thence S. 00°-25' E. 4 feet to an iron pipe monument FOR A PLACE OF TURNING; thence continuing S. 00°-25' E. 820.73 feet; thence S. 75°-42' W. 32.5 feet to a point of curve; thence easterly, in the arc of a circular curve to the right, of radius 510.00 feet, through a central angle of 18°-44' to the point of tangency; thence N. 84°-54' W. 162 feet to a point of curve; thence westerly, in the arc of a circular curve to the left, of radius 232.4 feet, through a central angle of 32°-54' to the point of tangency; thence in the arc of a circular curve to the left, of radius 52.96 feet, through a central angle of 21' to a point of tangency; thence S. 4°-49' E. 432.75 feet to the center line of Liberty Street; thence S. 75°-48' W. 487.72 feet to the easterly line of State Trunk Line 4-17; thence S. 49°-30' W. along said easterly line 739.72 feet to the line of "Boulevard Heights"; thence S. 89°-58'-30" E. along south line 84.60 feet to the southeast corner of "Boulevard Heights"; thence N. 00°-05'-30" W. along the east line of "Boulevard Heights" 780.74 feet; thence EAST parallel with the south line of "Jackson Heights" 1174.06 feet to the place of beginning.
