Ready for your rebate?

Follow these easy steps.

Step #1: Confirm the details

- » Commercial: Businesses must provide lawn/yard care or landscaping services to properties located within the City of Ann Arbor and provide documentation demonstrating that they serve customers within the city
- » You reserved funding and have a Rebate Reservation Number: osi.a2gov.org/rebates (optional)
- » Review sections and individual measures for eligibility requirements

Step #2: Attach a copy of your receipts and eligibility

- » Provide Rebate Reservation Number if applicable
- » Provide a copy of your trade in confirmation from Recycle Ann Arbor for trading in gas-powered equipment
- » Provide copies of all receipts; your receipt must clearly indicate the equipment type, make/manufacture, model, price, and date of purchase
- » Provide proof that your business serves customers in the City of Ann Arbor by one of the following methods: 1: Provide invoices, receipts, and/or contracts for three (3) residential customers or one (1) multifamily or commercial customer showing customer address(es) in the City of Ann Arbor. (Please redact customer names, phone numbers, and emails) OR 2: Provide Articles of Organization/Incorporation showing that your business address is in the City of Ann Arbor

Step #3: Submit your application

Commercial Yard Care Equipment

- » Businesses must provide lawn/yard care or landscaping services to properties located within the City of Ann Arbor and provide documentation demonstrating that they serve customers within the city. Contractor must 1: Provide invoices, receipts, and/or contracts for three (3) residential customers or one (1) multifamily or commercial customer showing customer address(es) in the City of Ann Arbor. (Please redact customer names, phone numbers, and emails) or 2: Provide Articles of Organization/Incorporation showing that the business address is in the City of Ann Arbor
- » To be eligible for a rebate, applicants must recycle a gas-powered piece of equipment of the same type as the equipment being purchased at Recycle Ann Arbor's Drop-Off Station and submit proof of trade-in with their rebate application
- » New equipment must be manual or electric/battery powered
- » Maximum \$5,000 in rebates per business; may apply for multiple rebates of the same type
- » If equipment is not purchased as part of a battery/charger kit, cost of up to two batteries and one charger may be included in rebate calculation
- » Required documentation: completed application; receipt including make, model, date of purchase, proof of payment; and proof of trade-in of eligible gas-powered equipment

- » Applicants will be given 90 calendar days to respond before application is deemed ineligible.
- » A rebate check will be mailed to you for qualified products. Please allow 6 to 8 weeks to receive your rebate check from the time your application is received.

A²ZERO Home Energy & Yard Care Rebate Program Terms and Conditions

Application

This application, along with any required additional documentation, must be truthful, complete, and accurately filled out. Applicants should retain a copy of this application and any accompanying documentation submitted to the A²ZERO Home Energy & Yard Care Rebate Program. The City of Ann Arbor and its contractors will not be responsible for lost documentation pertaining to this application request. Details of this program, including rebate levels, are subject to change or cancellation without prior notice. All applications and required documentation must be received within 90 days of the purchase/installation of eligible equipment or by June 30, 2026, whichever is earlier.

Limited Funds

Funds for rebates are limited and available on a first-come, first-served basis. Rebate amounts are valid through June 30, 2026, or until the fund limit for the year is reached, whichever is earlier. The City of Ann Arbor reserves the right to not pay a rebate if funds are not available at the time of application approval, or if the application is not complete and accurate, including all required additional information and documentation, or if the application is not submitted within the required time frame. The rebate amount may not exceed the pre-tax purchase price of the eligible equipment.

Eligibility

This offer is valid businesses providing Yard care or landscaping services to properties located in the City of Ann Arbor. Applicant and equipment must meet all program eligibility criteria. Equipment must be new and operational; refurbished and/or open-box products are not eligible for rebates. Limit one rebate per eligible measure/unit or as noted in each measure section. Applicant must be 18 years or older to be eligible for rebate.

Approval, Verification, and Inspection

Prior to any payment of rebates, the City of Ann Arbor reserves the right to verify sales transactions and installation compliance. No warranty is implied by this inspection.

Proof of Purchase

A receipt itemizing the purchased equipment must accompany each rebate application. The receipt must indicate the equipment type, make, model, price, serial numbers, and the date of purchase.

Payment

Once a completed application and all required additional documentation is submitted, a rebate payment is usually processed within 6 to 8 weeks. Rebate payments are made by check. Payment processing may take longer if information is missing on the application. Applicant may authorize payment of the rebate directly to the contractor.

Tax Liability

The City of Ann Arbor will not be responsible for any tax liability that may be imposed on the recipient of a rebate under the A²ZERO Home Energy & Yard Care Rebate Program as a result of the payment of the rebate. Applicants should contact their tax advisor for more information.

No Endorsement

The City of Ann Arbor does not endorse any manufacturer, product, system design, claim, or contractor in promoting this program.

Information Release

Applicants agree that the City of Ann Arbor may include their name, address, equipment/measures for which they received rebates, and resulting energy and CO₂e savings in a database, and such information may be included in reports or other documentation submitted to regulatory bodies. This information will be treated as confidential and will only be reported in the aggregate.

Release/Indemnification

Payment of rebates under the A²ZERO Home Energy & Yard Care Rebate Program and/or evaluation of applications for rebates does not make the City of Ann Arbor or any of its affiliates, employees, or agents responsible for any work completed.
