PLEASE NOTE A FIRST TIME PASS INCENTIVE.

1 & 2 Family Dwellings: first time pass on an initial inspection will extend the rental certificate by 1 year.

Multiple Dwellings (3 + units): must pass at least 70% of initial inspection with remaining violations completed within 60 days of initial to extend rental certificate by 1 year.

If all violations are not approved by the 2-re-inspection, enforcement action including posting of the property and/or ticketing may occur. If all violations are not approved by the 3-re-inspection, a ticket will be issued.

After one cancellation or no show during an inspection cycle, a subsequent cancellation or no show will result in the property being posted.
