

Home Energy Rebate Program Application

Follow these easy steps.

Step #1: Confirm the details

- » You own or rent a residential property located within the City of Ann Arbor
- » You meet income eligibility and have an Income Verification Number: osi.a2gov.org/rebates (optional)
- » You reserved funding and have a Rebate Reservation Number: osi.a2gov.org/rebates (optional)
- » Review sections and individual measures for eligibility requirements

Step #2: Attach a copy of your receipts and invoices

- » Provide Income Verification Number and/or Rebate Reservation Number if applicable
- » Provide copies of all receipts and/or invoices from product purchases or installations
- » Your receipt or invoice must clearly indicate the equipment type, make/manufacturer, model, price, and date of purchase or installation
- » For equipment requiring licensed contractor installation, include an invoice from the installing contractor detailing equipment installed and marked paid in full
- » For HVAC equipment a Manual J and an AHRI certificate must be submitted as documentation. For centrally ducted systems, post-installation static pressure testing and documentation required

HVAC & Water Heating

- » Central air-source heat pumps and mini-splits must be cold climate rated
- » Rebates for up to two mini-split systems are allowed per address; a mini-split system is defined as one outdoor unit connected to one or more indoor air handlers
- » Specific combination of indoor and outdoor models installed must be listed on ashp.neep.org
- » For centrally ducted systems, post-installation static pressure testing and documentation required
- » Licensed mechanical contractor installation is required. Dual-fuel heat pumps are not eligible
- » Required documentation: completed application; itemized contractor invoice with date of installation, make, and model, paid in full; completed Manual J and AHRI certificate

- » Rebates apply to both standard and cargo e-bikes
- » Required documentation: completed application; receipt including make, model, date of purchase, and proof of payment

Important Information

- » Incomplete applications cannot be processed for payment.
- » Applications must be received within 90 days of purchase and/or installation of measures and include invoices or receipts of purchase and required documentation showing eligible measures such as AHRI certificates for cold climate heat pumps, efficiency rating for heat pump water heaters, and UL certification for E-Bikes.
- » Notification of problems with incomplete applications will be sent via email or U.S. Mail.
- » Applicants will be given 90 calendar days to respond before application is deemed ineligible.
- » A rebate check will be mailed to you for qualified products. Please allow 6 to 8 weeks to receive your rebate check from the time your application is received.

A²ZERO Rebate Program Terms and Conditions

Application

This application, along with any required additional documentation, must be truthful, complete, and accurately filled out. Applicants should retain a copy of this application and any accompanying documentation submitted to the A²ZERO Rebate Program. The City of Ann Arbor and its contractors will not be responsible for lost documentation pertaining to this application request. Details of this program, including rebate levels, are subject to change or cancellation without prior notice. Rebate approvals are subject to funding availability and program requirements. All applications and required documentation must be received within 90 days of the purchase/installation of eligible equipment or by June 30, 2027, whichever is earlier.

Limited Funds

Funds for rebates are limited and available on a first-come, first-served basis. Application submission does not guarantee rebate payment if program requirements are not met. The City of Ann Arbor reserves the right to modify, suspend, or discontinue rebate offerings at any time. Rebate funds are available only while program funding remains available. The City of Ann Arbor reserves the right to deny a rebate if funds are unavailable at the time of final application approval, if the application is incomplete or inaccurate, or if required documentation is not submitted within the required timeframe. The rebate amount may not exceed the pre-tax purchase price of the eligible equipment.

Eligibility

This offer is valid only for owners or residents of residential property located in the City of Ann Arbor. Applicants must be 18 years or older to be eligible. Eligible measures must meet all requirements listed within their respective measure categories.

Approval, Verification, and Inspection

Prior to any payment of rebates, the City of Ann Arbor reserves the right to verify sales transactions, equipment installation, and compliance with program requirements. Applicant and/or their contractor must comply with all applicable building codes, zoning laws, and local, state, and federal requirements. Applicant is responsible for obtaining any applicable permits as required. The City of Ann Arbor may conduct inspections, request additional documentation, or otherwise verify compliance with program requirements prior to issuing rebate payments.

Proof of Purchase

An invoice, receipt, purchase agreement, or other documentation acceptable to the City of Ann Arbor must accompany each rebate application. Documentation must indicate the eligible measure purchased, the purchase date, price, and any other information required by the applicable measure section. For measures requiring contractor installation, an invoice from the installing contractor detailing equipment installed must accompany the application.

Payment

Unless otherwise stated, if the cost of the equipment/measure is less than the standard rebate amount, the rebate payment will be pro-rated to 90% of the pre-tax cost of the eligible equipment/measure. Once a completed application and all required additional documentation is submitted, a rebate payment is usually processed within 6 to 8 weeks. Rebate payments are made by check. Payment processing may take longer if information is missing on the application. Applicant may authorize payment of the rebate directly to the contractor.

Tax Liability

The City of Ann Arbor will not be responsible for any tax liability that may be imposed on the recipient of a rebate under the A2ZERO Rebate Program as a result of the payment of the rebate. Applicants should contact their tax advisor for more information.

No Endorsement

The City of Ann Arbor does not endorse any manufacturer, product, system design, claim, or contractor in promoting this program.

Information Release

Applicants agree that the City of Ann Arbor may include their name, address, equipment/measures for which they received rebates, and resulting energy and CO2e savings in a database, and such information may be included in reports or other documentation submitted to regulatory bodies. This information will be treated as confidential and will only be reported in the aggregate.

Release/Indemnification

Payment of rebates under the A2ZERO Rebate Program and/or evaluation of applications for rebates does not make the City of Ann Arbor or any of its affiliates, employees, or agents responsible for any work completed. Applicant fully releases and agrees to defend, indemnify, and hold harmless the City of Ann Arbor and its affiliates, employees, and agents from any claims in connection with the application, the rebates, and the work performed in connection with the A2ZERO Rebate Program.
