### II. QUESTIONS AND ANSWERS

The following Questions have been received by the City. Responses are being provided in accordance with the terms of the ITB. Respondents are directed to take note in its review of the documents of the following questions and City responses as they affect work or details in other areas not specifically referenced here.

**Question 1**: Will contractors be able to park onsite without having to pay?

**Answer 1**: Yes, contractors can park in the middle of the lot that is not metered when they are on-site working only.

- **Question 2:** Will water and electricity be available?
- Answer 2: Yes, water and electricity are available on site.
- Question 3: What type of concrete patch and epoxy will be permitted?
- **Answer 3:** The following types/brands will be permitted.

**Concrete Patching:** 

- a. "EUCO Poly-patch," Euclid Chem. Co.
- b. "Sikatop 144," Sika Chem. Corp.
- c. "MasterEmaco N 220," Masterbuilders, Inc.

Epoxy for Anchor Bolts:

- a. "AC100+ Gold," Powers Fasteners, Inc.
- b. "Epcon G5," ITW Ramset/Red Head.
- c. "SET," Simpson Strong-Tie Co., Inc.
- d. "HIT-HY 100," Hilti, Inc.
- **Question 4:** Is there a lower limit for requiring bid bonds?
- **Answer 4:** Bid bonds are required for this ITB regardless of amount.
- Question 5: Do we have an estimated start / completion date for this project?
- **Answer 5:** The project will need to be approved by City Council, which will most likely be in June, so construction will most likely start in June or early July. The shorter the period of time that there is disruption to the site, the better, but the project must be complete by September 1, 2016.
- Question 5: Is there a designated area for staging of our materials and equipment?
- Answer 5: Contractors may stage materials, if needed, in the center of the lot where contractors may park. However, it is not a secure site, and leaving materials is at the risk of the contractor.

**Question 6:** Are there any permits we should expect to include in our bid, right of way closure/lane closure?

**Answer 6:** Permits should not be needed for this project.

Question 7: What dates is the farmers market open?

**Answer 7:** The market is open on Wednesdays and Saturdays. No work will be permitted on market days.

Bidders are responsible for any conclusions that they may draw from the information contained in the Addendum.
