DESCRIPTION OF LAND PLATTED

The land embraced in the annexed plat of ASSESSOR'S PLAT No. 45 part of the NW of Sec. 31, T 2 S, R 6 E, City of Ann Arbor, Washtenaw County, Michigan.

Commencing at the NW corner of Sec. 31, T 2 S, R 6 E, City of Ann Arbor, Washtenaw County, Michigan; thence along the North line of Sec. 31, S 89°-51' E 735.26 feet for a PLACE OF BEGINNING; thence continuing along said North line S 89°-51' E 673.19 feet to the center line of Stadium Boulevard; thence along the center line of Stadium Boulevard 297.50 feet in the arc of a circular curve concave to the northeast, radius 2279.67 feet, chord S 33°-36'-40" E 297.31 feet; thence S 89°-43'-20" W 350.13 feet; thence N 37°-21' W 458.75 feet; thence S 89°-43'-20" W 156.36 feet; thence S 89°-43'-20" W 156.36 feet; thence S 89°-43'-20" W 156.36 feet; thence S 257.31 feet in the arc of a circular curve concave to the Northeast, radius 278.55 feet, chord N 63°-48'-50" W 248.26 feet; thence N 37°-21' W 385.94 feet to the place of beginning, containing seven lots numbered one through seven inclusive and one outlot lettered "A".
