# I. QUESTIONS AND ANSWERS

The following Questions have been received by the City. Responses are being provided in accordance with the terms of the RFP. Respondents are directed to take note in its review of the documents of the following questions and City responses as they affect work or details in other areas not specifically referenced here.

Question 1: Section 1 General Information F. (Page 5)

Is there a certain format or form that the city would like submitted in the fee proposal? Response 1: No, the City does not have a particular form but additional information regarding what the fee proposal should contain is listed in Section III, Item D (Page 13).

- Question 2: Exhibit C Insurance Requirements (Page 33) Can the requirement of Professional Liability be waived seeing as how there isn't any Professional engineering work i.e. Design drawings, specifications, reports, recommendations required in the RFP?
- Response 2: Yes, Professional Liability Insurance will not be required for this contract.

- Question 3: Is intrinsically safe equipment required as part of this project.
- Response 3: No, the City does not require intrinsically safe equipment however the contractor is responsibility for safety related to his/her performance on this project.
- Question 4: Will permits (e.g. Lane Closure, Parking Meter Bagging) be required and what will the cost be?
- Response 4: Yes, the contractor will be responsible for obtaining all city permits, however the fees will be waived for any permit needed.
- Question 5: Will there be work restrictions during Art Fair and/or weekends?
- Response 5: The typical work hours are 7am-8pm, Monday through Saturday. On major roads, lane closures are only allowed from 9am-3pm. The City will work with the contractor on specific restrictions during such events as Art Fair and football games.
