## Current Security Measures at Haisley Elementary

The Ann Arbor Police Department has learned the defendant in this case has posted bond and is scheduled to be released the morning of January 30, 2026. Our department is working closely with Ann Arbor Public Schools to support student and staff safety. AAPD will have officers at Haisley Elementary School for the duration of the school day starting Friday, January 30 through February 5, 2026. The defendant has a probable cause hearing on February 5, and AAPD will assess and coordinate a safety plan with AAPS based on the outcome of the hearing. Future updates will be communicated through our 'Community Updates' section on the AAPD website.

## What are the bond conditions for the defendant?

The magistrate set the bond amount at \$250,000. The defendant has posted bond and will be released the morning of January 30, 2026.

The magistrate imposed the following conditions. He will be required to wear a GPS location-tracking tether. Other bond conditions include: no consumption of alcohol; no possession of any weapons; no criminal activity; no travel outside the state of Michigan; no presence on any Ann Arbor Public Schools property or at any Ann Arbor Public Schools event, including Haisley Elementary; and no contact with any Ann Arbor Public Schools employees.

## How can a community member learn if a defendant is released?

[VINELink](#) is the online, 24/7, and free portal for the VINE (Victim Information and Notification Everyday) system, which allows victims of crime and the public to track the custody status and criminal case information of offenders in jails or prisons.

Victims and other concerned community members can register to be notified by phone, email, or TTY device when an offender's custody status changes. Search by clicking on the Offender or Offender with Court Cases tab. Enter case ID or offenders' name, click on the offender's name, then register for notification to receive automated telephone calls, emails or TTY notification. The PIN (Personal Identification Number) must be remembered to confirm calls from the automated service and to stop repeated calls. Users can also register through the Michigan State's toll-free number 800-770-7657.

### **How will the victim get updates on this case?**

The victim in this incident has been assigned a victim advocate through the Washtenaw County Prosecutor’s Office. The advocate will provide ongoing information and updates to the victim as the case progresses through the legal process.

 b. The bond previously ordered is continued, and the defendant/juvenile shall comply with the terms and conditions in item 5.
5. The defendant/juvenile shall comply with the following terms and conditions that are checked:
  - a. Personally appear for any examination, arraignment, trial, sentencing, or at any time and place as directed by this court. If represented by an attorney in this case, any notice to appear may be given to the defendant's attorney instead of the defendant.
  - b. Abide by any judgment entered in this case and surrender to serve any sentence imposed.

c. Do not leave the State of Michigan without the permission of this court.

d. Do not commit any crime while released.

e. Immediately notify this court, in writing, of any change of address or telephone number.

f. Make reports to a court agency as specified by this court or the agency.

g. Do not use  alcohol,  marijuana,  illegal controlled substances.

h. Participate in a substance abuse testing or monitoring program.

i. Participate in a specified treatment program for any physical or mental condition, including substance abuse.

j. Comply with restrictions on personal association, place of residence, place of employment, or travel.

k. Surrender driver's license or passport.

l. Continue to seek employment.

m. Comply with the following curfew:

n. Continue or begin an educational program.

o. Remain in the custody of a responsible member of the community. The community member agrees to monitor the defendant/juvenile and report any violation of these release conditions to the court.

p. Do not possess or purchase a firearm or other dangerous weapon.

q. Do not harass, intimidate, beat, molest, wound, stalk, threaten, or engage in other conduct that would place any of the following persons or a child of any of the following persons in reasonable fear of bodily injury: spouse, former spouse, individual with whom the defendant has a child in common, resident or former resident of the defendant's household.
