Section/Page(s)	Change
BF-1	Add an allowance of \$1,750.00 for any cracking of the plaster ceiling in the caretaker's house due to roof replacement (see question 4 below)
Clarification:	The roofing replacement is limited only to the removal and replacement of the existing roofing, sheathing and installation of new batt insulation as described on the drawings and specifications. Any existing building geometries out of square can remain.

plaster ceiling by roofing replacement is to be provided. Contractor, Owner and

Architect to field verify existing plaster ceiling condition prior to roofing

replacement.

Question 5: What will happen with the residents in the caretaker's house during roof and

window replacement?

Answer 5: Staff will not be occupying the structure during construction.
