Electric Vehicle Rebate

- » Applicants must be residents of the City of Ann Arbor.
- » Applicants must be at least 18 years of age.
- » There is a limit of one rebate, regardless of category, per household or business.
- » Eligible vehicles must be battery electric vehicles (BEVs) powered solely by electricity and charged by plugging into external charging equipment. Hybrid electric vehicles (HEVs) and plug-in hybrid electric vehicles (PHEVs) are not eligible. Vehicles may be new or used and must have four wheels, a battery capacity of at least 10 kWh, and a maximum speed of at least 55 mph. Leased vehicles must have an initial lease term of at least thirty-six (36) months to qualify for a rebate.
- » Eligible vehicles must be purchased or leased from a licensed motor vehicle dealer on or after May 1, 2026, and registered to an eligible Ann Arbor household.
- » Rebates may not exceed 90% of the purchase price of the eligible vehicle.
- » As a condition of receiving a rebate, applicants agree to complete brief program surveys annually for the first two (2) years following rebate payment. Survey responses will be used by the City of Ann Arbor to evaluate program participation, vehicle usage, and program impacts.

A²ZERO Rebate Program Terms and Conditions

Application

This application, along with any required additional documentation, must be truthful, complete, and accurately filled out. Applicants should retain a copy of this application and any accompanying documentation submitted to the A2ZERO Rebate Program. The City of Ann Arbor and its contractors will not be responsible for lost documentation pertaining to this application request. Details of this program, including rebate levels, are subject to change or cancellation without prior notice. Reservation approvals are subject to funding availability and program requirements. A completed rebate application and all required documentation must be submitted within 90 days of reservation approval.

Limited Funds

Funds for rebates are limited and available on a first-come, first-served basis. Reservation approval does not guarantee rebate payment if program requirements are not met. The City of Ann Arbor reserves the right to modify, suspend, or discontinue rebate offerings at any time. Rebate funds are available only while program funding remains available. The City of Ann Arbor reserves the right to deny a rebate if funds are unavailable at the time of final application approval, if the application is incomplete or inaccurate, or if required documentation is not submitted within the required timeframe.

Eligibility

This offer is valid only for owners or residents of residential property located in the City of Ann Arbor and businesses that meet the eligibility requirements described in the applicable measure section of this application. Applicants must be 18 years or older to be eligible. Eligible measures must meet all requirements listed within their respective measure categories. Electric vehicle rebates are subject to additional eligibility, ownership, registration, lease, and survey requirements described in the Electric Vehicle section of this application.

Approval, Verification, and Inspection

Prior to any payment of rebates, the City of Ann Arbor reserves the right to verify sales transactions, vehicle ownership and registration, equipment installation, and compliance with program requirements. Applicant and/or their contractor must comply with all applicable building codes, zoning laws, and local, state, and federal requirements. Applicant is responsible for obtaining any applicable permits as required. The City of Ann Arbor may conduct inspections, request additional documentation, or otherwise verify compliance with program requirements prior to issuing rebate payments.

Proof of Purchase

An invoice, receipt, purchase agreement, lease agreement, or other documentation acceptable to the City of Ann Arbor must accompany each rebate application. Documentation must indicate the eligible measure purchased, the purchase or lease date, price, and any other information required by the applicable measure section. For measures requiring contractor installation, an invoice from the installing contractor detailing equipment installed must accompany the application.

Payment

Unless otherwise stated, if the cost of the equipment/measure is less than the standard rebate amount, the rebate payment will be pro-rated to 90% of the pre-tax cost of the eligible equipment/measure. Once a completed application and all required additional documentation is submitted, a rebate payment is usually processed within 6 to 8 weeks. Rebate payments are made by check. Payment processing may take longer if information is missing on the application. Applicant may authorize payment of the rebate directly to the contractor.

Tax Liability

The City of Ann Arbor will not be responsible for any tax liability that may be imposed on the recipient of a rebate under the A²ZERO Rebate Program as a result of the payment of the rebate. Applicants should contact their tax advisor for more information.

No Endorsement

The City of Ann Arbor does not endorse any manufacturer, product, system design, claim, or contractor in promoting this program.

Information Release

Applicants agree that the City of Ann Arbor may include their name, address, equipment/measures for which they received rebates, and resulting energy and CO₂e savings in a database, and such information may be included in reports or other documentation submitted to regulatory bodies. This information will be treated as confidential and will only be reported in the aggregate.

Release/Indemnification

Payment of rebates under the A²ZERO Rebate Program and/or evaluation of applications for rebates does not make the City of Ann Arbor or any of its affiliates, employees, or agents responsible for any work completed. Applicant fully releases and agrees to defend, indemnify, and hold harmless the City of Ann Arbor and its affiliates, employees, and agents from any claims in connection with the application, the rebates, and the work performed in connection with the A²ZERO Rebate Program.
