I. QUESTIONS AND ANSWERS

The following Questions have been received by the City. Responses are being provided in accordance with the terms of the RFP. Respondents are directed to take note in its review of the documents of the following questions and City responses as they affect work or details in other areas not specifically referenced here.

- Question 1: What is the scope of plumbing mechanical changes that are to be completed during the water meter replacement?
- Answer 1: Unknow per location, but will vary most likely to different meter lay lengths. Contractor is expected to review in advance and facilitate appropriate changes to install the new meter.
- Question 2: Will a plumbing contractor's license be required for any plumbing modifications? Will a plumbing permit be required and if so, how much is the permit fee?
- Answer 2: Yes, a contractor's license will be required to perform the services. Plumbing permits will be required and permit fee schedule has been attached.
- Question 3: What is the meter type? What is the radio type? Will there be programming involved?
- Answer 3: Replacement water meters 3" and larger will be Honeywell evoQ4 meters and under 3" will be Badger meters. The RTU is an Aclara unit. No programming is required by the contractor, as the City will facilitate the programming.

Question 4: Can you please provide us with an accurate breakdown of the meters being replaced? How many are 2", 3", 4"?

Question 5: Are they going longer or shorter? If we are replacing disc or ultrasonic, they should

be the same or longer than the replacement, turbo meters will be shorter and

require plumbing.

Answer 5: All are believed to be shorter lay length than what is currently in place, requiring

plumbing alterations.

Question 6: Are meters located in confined space? If, so, how many and what size are the

meters?

Answer 6: None of the proposed replacements involve confined space entry. The

replacements require plumbing changes to the existing mechanical layout of the

commercial facilities that the City is not permitted to conduct directly.

Question 7: Do water meters have a by-pass?

Answer 7: It is not known if the current services have by pass installations. Some of the

changes may require after-hours coordination in scheduling.

- A permit shall become invalid if the authorized work is not commenced within 180 days after issuance of the permit or if the authorized work is suspended or abandoned for a period of 180 days after the time of commencing the work.
- 2. A permit will be closed when no inspections are requested and conducted within 180 days of the date of issuance or the date of a previous inspection.
- 3. Closed permits cannot be refunded. The charge to re-open a closed permit is \$35.00.
