## February 5, 2026, UPDATE:

Following today's adjourned hearing, we want to reiterate that an officer will remain assigned to Haisley through Friday, February 6. Beginning next week, the Ann Arbor Police Department will continue to conduct regular patrols throughout the Haisley neighborhood.

## January 30, 2026, UPDATE:

An emergency bond hearing was held on Friday, January 30, 2026, at 14A-1 District Court for 18-year-old Jules Khalfoun. During the hearing, bond conditions were modified to require Khalfoun to be placed on home confinement (house arrest) at a relative's residence upon release on bond. As part of the bond conditions, Khalfoun was placed on a GPS tether. He bonded out and was released from the Washtenaw County Jail during the evening of January 30, 2026.

AAPD is working closely with Ann Arbor Public Schools to support student and staff safety. Officers will be present at Haisley Elementary School during the school day through February 5, 2026. The defendant has a probable cause hearing on February 5, and AAPD will assess and coordinate a safety plan with AAPS based on the outcome of the hearing.

AAPD has also implemented a security plan in the area where the defendant is currently on home confinement.

The conditions of the defendant's release also include stipulations for how he will receive mental health treatment.

AAPD leadership has been meeting with the victim to provide updates and has assigned a Lieutenant to discuss any of their ongoing concerns.


**STIPULATED ORDER FOR RELEASE FROM CUSTODY**

NOW COMES the Defendant, JULES ANGE-LEWIS KHALFOUN, by his Attorney, Delphia T. Simpson, Chief Public Defender for Washtenaw, and states:


1. Defendant is being held on charges regarding Case No. 26F5-5510-FY.
2. That Defendant is being charged False Report or Threat of Terrorism and Intentional Threat of Violence Against School, School Employees or Students.
3. Defendant was given a \$250,000 cash or surety bond on January 28, 2026, by the Court.
4. Defendant is in jeopardy of mental decompensation due to Autism Spectrum Disorder, ADHD, Imminent Explosive Disorder, and Mood Disorder. Defendant requires treatment and therapeutic services, which includes medication and counseling.
5. At the Emergency Motion for Reconsideration held before the Court on January 30, 2026, the prosecution withdrew their request for an increase in bond and stipulated to the following:
  - a. Defendant shall be released on a GPS tether with home confinement to [REDACTED]
  - b. Defendant shall possess no weapons, and the [REDACTED] address shall be inspected for weapons prior to release.
  - c. Defendant shall not enter upon the premises of Haisley School in Ann Arbor, Michigan.

- d. Defendant may only leave the [REDACTED] address for necessary appointments, including [REDACTED] Mental Health, on [REDACTED] for initial intake assessment— [REDACTED]
- e. Defendant may leave the [REDACTED] address for any necessary follow-up care with [REDACTED] Mental Health.
- f. Defendant may leave the [REDACTED] address for a psychiatric evaluation with [REDACTED] [REDACTED]
- g. Defendant may leave the [REDACTED] address for any necessary follow-up care with [REDACTED]
- h. Defendant may leave the [REDACTED] address for any and all court hearings scheduled in this matter.
- i. Defendant shall notify community corrections tether monitoring agent prior to any scheduled medical appointment.
- j. All other bond conditions previously set by Magistrate Odatella continue.


