AN ORDINANCE TO AMEND SECTIONS 5.15 AND 5.16 OF CHAPTER 55 (UNIFIED DEVELOPMENT CODE) OF TITLE V OF THE CODE OF THE CITY OF ANN ARBOR

The City of Ann Arbor ordains:

Section 1. That Table 5.15-1 Primary Use Table in Section 5.15.1 of Chapter 55 (Unified Development Code) of Title V of the Code of the City of Ann Arbor be amended as follows:

Section 2. That Section 5.16.3.D of Chapter 55 (Unified Development Code) of Title V of the Code of the City of Ann Arbor be amended as follows and renumbered accordingly:

~~D. General Entertainment~~

~~1. Theatre, Enclosed~~

~~a. C1B District~~

~~The total seating capacity shall not exceed 600 seats.~~

~~2. Pinball Parlor~~

~~Allowed only in the C1A District.~~

Section 3. This ordinance shall take effect and be in force on and after ten days from legal publication.
