RE: Arella Boulevard (Stadium Boulevard – Pauline Boulevard): Results of Final Polling

Dear Arella Boulevard Residents and Owners,

Thank you for your interest in Traffic Calming on Arella Boulevard. Following an initial questionnaire, orientation meeting, and self-guided tour meeting, a final poll was conducted to determine support for traffic calming within the project area.

The program guidelines specify that, “greater than 50% of returned final polls must indicate support (‘yes’) for the final plan”. This letter is to inform you that the results have been officially tallied and **the project has received enough support to move forward**. The breakdown of the final poll results are as follows:

- 45 Addresses in project area
- 23 Final poll responses received
- 13 Final polls supporting the final plan
- 56.5% Percent of final polls received support the final plan as shown.

This project has met the required criteria to be considered for construction at these upcoming, electronic, public meetings; public comment opportunities are available:

- **February 2024** – Transportation Commission to consider a recommendation; details: a2gov.org/TransportationCommission
- **March 2024** – City Council to consider a resolution for construction approval; details: a2gov.org

If approved by City Council, construction is tentatively planned to be completed during the 2024-2025 construction season based on available funding. The outcome of the Transportation Commission and City Council meetings will be posted on the project website, a2gov.org/TCArellaSP.
