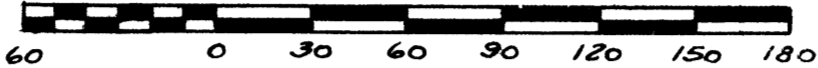


"LASALLE SUBDIVISION"

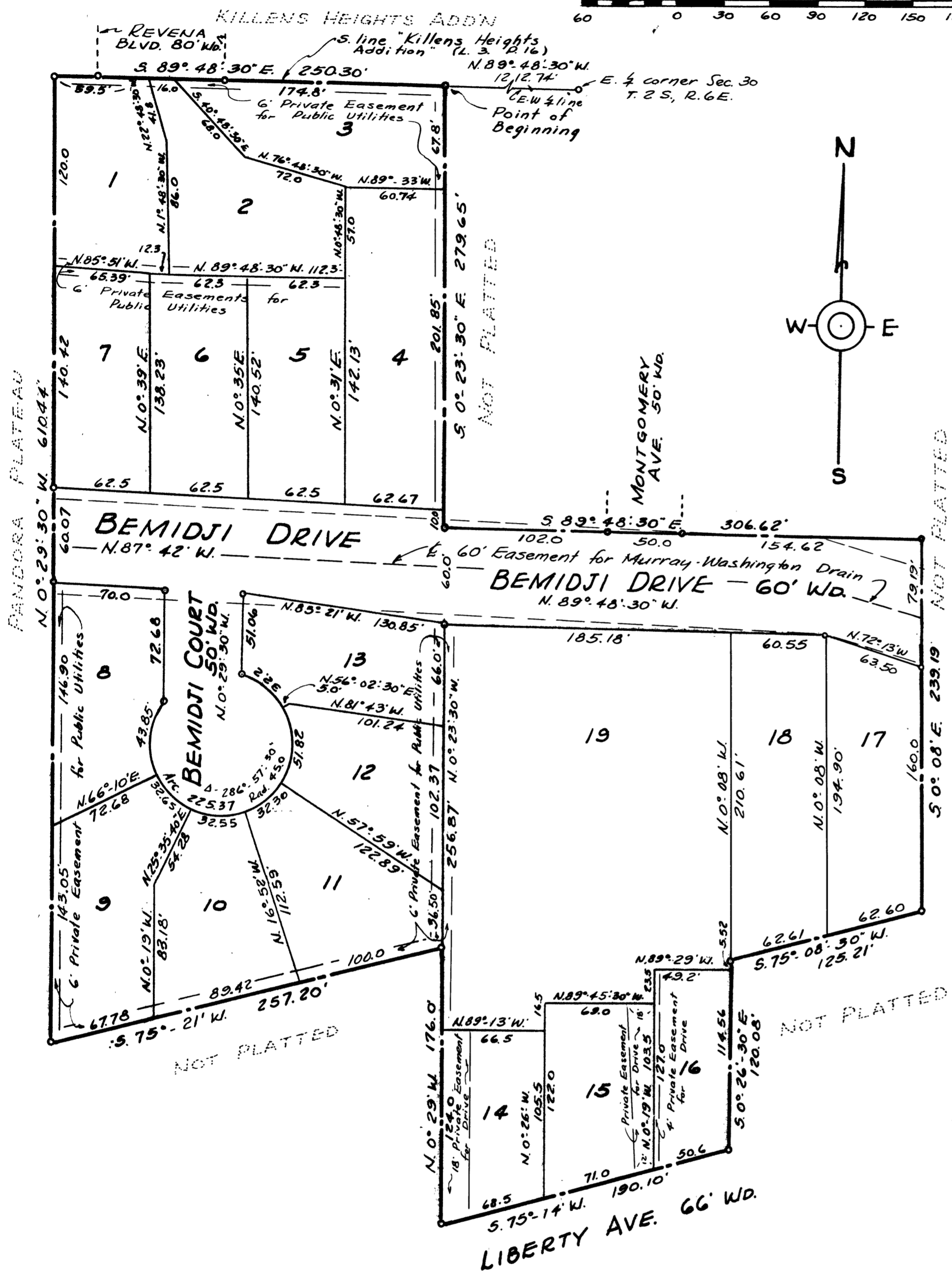
OF PART OF THE SE 1/4 OF SEC. 30, T. 2 S., R. 6 E.,

DESCRIPTION OF LAND PLATTED

The land embraced in the annexed plat of "LaSalle Subdivision" of part of the SE 1/4 of Sec. 30 T. 2 S., R. 6 E., City of Ann Arbor, Washtenaw County, Michigan is described as: Beginning at a point on the south line of "Killens Heights Addition" (L. 3 P. 16) distant N. 89°-48'-30" W., along the E-W 1/4 line of said Sec. 30, 1212.74 ft. from the E 1/4 corner of said Section 30, thence S. 0°-23'-30" E., 279.65 ft.; thence S. 89°-48'-30" E., 306.62 ft.; thence S. 0°-08'-E., 239.19 ft.; thence S. 75°-08'-30" W., 125.21 ft., thence S. 0°-26'-30" E., 120.08 ft. to the N'y line of Liberty Ave. (66 ft. wide) thence S. 75°-14' W., along said N'y line of Liberty Ave., 190.10 ft.; thence N. 0°-29' W., 176.0 ft.; thence S. 75°-21' W., 257.20 ft.; thence N. 0°-29'-30" W., 610.44 ft. to the South line of "Killens Heights Addition"; thence S. 89°-48'-30" E., along said south line 250.30 ft. to the point of beginning containing Lots 1 through 19 inclusive,
