## 1/28/26 2:20 P.M. UPDATE

This afternoon, 18-year-old Jules Khalfoun of Ann Arbor was arraigned in 14A-1 District Court on two counts: Making Terrorist Threats and Intentional Threat to Commit an Act of Violence Against a School, School Employees, or Students.

Khalfoun was issued a \$250,000 cash/surety bond. If released, he will be required to wear a GPS location-tracking tether. Other bond conditions include: no consumption of alcohol; no possession of any weapons; no criminal activity; no travel outside the state of Michigan; no presence on any Ann Arbor Public Schools property or at any Ann Arbor Public Schools event, including Haisley Elementary; and no contact with any Ann Arbor Public Schools employees.

Khalfoun remains lodged at the Washtenaw County Jail. A probable cause hearing is scheduled for February 5, 2026, at 9 a.m.

## 1/28/26 1 P.M. UPDATE

The 18-year-old suspect who is alleged to have made threats at Haisley Elementary School on January 16, 2026, was taken into custody this morning by the Ann Arbor Police Department. The suspect has been transported to the Washtenaw County Jail on the following charges: Count 1: Threat of Terrorism; Count 2: Intentional Threat to Commit Act of Violence Against a School, School Employees, or Students.

The suspect will be arraigned at the 14A-1 District Court and bond will be determined by the Judge or Magistrate. Further updates on this case are being led and managed through the Washtenaw County Prosecutor's Office.

## 1/17/26 MEDIA RELEASE

On 1/16/26 at approximately 4 p.m., officers responded to Haisley Elementary School in response to serious and violent threats to harm people with a firearm. These threats came as school was being dismissed.

The Ann Arbor Police Department conducted a search of the 18-year-old suspect's residence where no firearms were found. AAPD also worked with Community Mental Health, which developed an immediate plan to get the person coordinated resources. He is currently receiving treatment at a medical facility.

On 1/17/26, the Washtenaw County Prosecutor's Office authorized the following charges: one count of making terroristic threats (a felony with a maximum 20-year sentence), and one count of making schools threats (a misdemeanor with a maximum 1-year sentence).

AAPD and Ann Arbor Public Schools have a plan to ensure the school's safety in place.

Investigators determined the 18-year-old was the sole person responsible for this incident.
