Safety Update Workers Memorial Day

The Occupational Safety and Health Act, OSH Act, went into effect on April 28, 1971. This Act created the Occupational Safety and Health Administration (OSHA) which was given the authority to set and enforce workplace safety and health standards. Since the passing of this act, incredible progress has been made in reducing workplace accidents, however creating safer workplaces is a job that is never finished as long as people continue to lose their lives in preventable accidents. In 2024, the Michigan Occupational Safety and Health Administration reported that there were 31 occupational fatalities in our state. April 28th, 2025, is Worker Memorial Day, where we recognize fallen workers and rededicate ourselves to making the places where we work as safe and healthy as possible. *Thank you for making A2 Be Safe!*

Fiscal Years 2026/2027 Budget Process Underway. The City of Ann Arbor two-year budget process for fiscal years 2026/2027 is underway. Fiscal year 2026 begins July 1, 2025, and ends June 30, 2026. City Council members can only adopt one fiscal year at a time, even though the city plans for multi-year budgets.

Budget timeline

March 24, 2025: City Council Work Session was held for FY26 Budget Planning

April 21: In accordance with City Charter, the city administrator's recommended fiscal year 2026 budget is submitted to City Council in April. City Council members can only adopt one fiscal year at a time even though the city plans for multi-year budgets.

May: City Council, with at least seven affirmative votes, will vote to adopt the budget at its meeting on May 19.

Ann Arbor Comprehensive Land Use Plan Draft Public Engagement Sessions. The City of Ann Arbor is charting its course for affordable, sustainable, equitable and dynamic land uses for the next 25 years. The Ann Arbor Comprehensive Land Use Plan draft is now available for public review on the new online platform for city projects, Engage Ann Arbor (EA2), at plan.a2gov.org/plan24. Here, community members can also find project

information, timeline and recordings and materials from previous meetings for the comprehensive plan project.

The city is now inviting the public to learn about and share input for the draft Ann Arbor Comprehensive Land Use Plan. Three engagement sessions are scheduled to review and discuss the plan draft with planning staff, to ask questions and to provide feedback. All are welcome to attend.

Over 70% Renewable Energy Now Powers City Operations. Over 70% of the electricity used to power City of Ann Arbor facilities and operations is now generated by renewable energy sources, the city is announcing. This achievement comes after 67 more city sites were enrolled in Michigan's Electric Customer Choice Program, which allows customers to make their own choices about how their energy is generated. The city's alternative energy supplier is Constellation Energy, the nation's largest producer of carbon-free energy. Seven city sites were already signed onto similar contracts. Now at 74 sites overall, just over 70% of Ann Arbor's overall electricity usage for its operations is generated from renewable energy sources pulled off the grid. In addition to this, solar at Ann Arbor city facilities generated almost 600 megawatt hours of additional electricity in 2024, a small but growing portion of overall usage. Over 2 megawatts of additional behind-the-meter solar systems are planned for city facilities in the coming two years, with some currently being installed. Together, this work is helping the city make notable strides toward its goal of powering all of its operations with renewable energy. Enforcement of 2021 International Fire Code to Begin April 27, 2025. On April 27, 2025, the Ann Arbor Fire Department will begin enforcing safety requirements outlined in the 2021 International Fire Code. This transition, **approved April 7 by City Council**, will enhance fire protection operations, compliance with industry advancements and public safety, ensuring regulations remain current and effective. Enforcement of 2021 Michigan Building Code Begins May 1, 2025. The City of Ann Arbor wants local developers, architects and builders to be aware, enforcement of the 2021 Michigan Building Code (MBC) will begin effective May 1, 2025. Any building permit applications submitted on or after this date must comply with the updated code requirements. Residential Code will remain 2015 Michigan Residential Code until the State of Michigan adopts an updated Residential Code. 




