Safety Update Summer Weather

As summer marches along, it is important that you are prepared for warm weather by taking some simple precautions and by making use of some resources. First and foremost, check the forecast so that you can plan accordingly. The CDC's Heat Risk website allows you to enter your zip code to get today's heat risk rating, along with helpful tips. In addition, the Washtenaw County Health Department has safety tips, and a listing of local cooling sites for those who may need a place to go to cool off. Some simple things you can do to stay prepared for warm weather include:

- Limit your exposure by performing physically demanding work or exercise during the cooler hours of morning and evening.
- If you must be outside during the peak heat, schedule frequent rest periods with water breaks in shaded or air-conditioned areas.
- Be able to recognize the <u>signs and symptoms</u> of heat stress: heat cramps, heat exhaustion, and heat stroke.
- Drink plenty of cool water and hydrating liquids with electrolytes and wear breathable clothing when
 possible that minimizes heat stress. Thank you for making A2 Be Safe!

New Fiscal Year, New Rebates! As of July 1, 2025, all Home Energy Rebate categories will be refreshed. Categories that ran out of money in the previous fiscal year are open and available to be drawn from again! Learn more and finance your home energy improvements at osi.a2gov.org/rebates.

Green Rental Housing Ordinance – Office of Sustainability and Innovations staff have been working for four years with community stakeholders to craft a new Green Rental Housing Ordinance. The Ordinance was passed by council in June 2025 and will help protect the health, safety, and well-being of renters across the city. To learn the facts about the Ordinance, we encourage residents to visit the Green Rental Housing Ordinance webpage.

Electric Leaf-blower compliance: The use of gas-powered leaf blowers is prohibited within Ann Arbor city limits June 1 – September 30, 2025. The purpose of this ordinance is to protect the health and welfare of Ann Arbor residents as well as to promote the City's sustainability goals by reducing noise, air pollution, greenhouse gas emissions, and other negative effects of gas leaf blowers. You can report violations of the ordinance to the Ann Arbor Police Department Community Standards at (734)-794-6942. Ann Arbor Introduces First Executive Director of Sustainable Energy Utility. The City of Ann Arbor is announcing the hiring of Shoshannah Lenski as the first executive director of the Ann Arbor Sustainable Energy Utility (SEU), effective Aug. 25, 2025.

Lenski brings a wealth of experience and leadership in sustainability, strategy and utility operations. She most recently served as associate director of the University of Michigan Center for Sustainable Systems and previously held several executive roles at DTE Energy, including director of gas strategy, director of enterprise performance management, and director of infrastructure renewal operations. Additionally, she has served as a consultant for the globally recognized Boston Consulting Group.

Lenski holds degrees from Cornell University and the University of Michigan and is deeply familiar with the Ann Arbor community. She spent six years serving on the Ann Arbor Energy Commission, including a term as chairperson.

"We are thrilled to welcome Shoshannah Lenski as the inaugural executive director of our SEU," said Ann Arbor City Administrator Milton Dohoney Jr. "Shoshannah's background and proven leadership make her uniquely

qualified to lead this transformative initiative. Just as importantly, she has a deep passion for Ann Arbor and a strong desire to be part of our community's future. In her, we have found both the expertise, and the passion to bring Ann Arbor's SEU to fruition."

The Ann Arbor SEU is a first-of-its-kind initiative designed to create a resilient, renewable-powered local energy system, one of the city's most ambitious climate and equity goals supported by voters.

"The hiring of Shoshannah marks a milestone in our collective efforts to reimagine how energy is produced, distributed, and consumed in our community," said Dr. Missy Stults, director of the Ann Arbor Office of Sustainability and Innovations. "This moment would not be possible without the voters' support — and it's worth noting that this journey started with a bold idea, a lot of community input, and a vision for a better energy future. I'm incredibly grateful to all who helped shape the path to this moment and beyond excited to see Shoshannah step into this critical leadership role."

Lenski will report to the city administrator and work closely with the office of sustainability and innovations and other city service areas to launch the SEU. Learn more about the **Ann Arbor SEU**.



Get ready for the Aug. 5 election. The Special Election will be held in Ann Arbor Tuesday, Aug. 5, with polling places open 7 a.m. –8 p.m. Here are some notes to know now:

Do you need to register to vote in Ann Arbor? Check your voter registration status, and if you're not already, register online to vote through the Michigan Voter Information Center. City residents can also

submit a voter registration form by mail, email, fax or in-person at the Ann Arbor City Clerk's office.

Voters on the permanent absent voter (AV) application list should have already received their AV applications in the mail in May or June. If you're interested in voting absentee or to learn more, find all the details on the city absentee voting page.

Registered voters in Ann Arbor can vote as early as five days before Special Election Day — Wednesday, July 30—Sunday, Aug. 3 — at any one of these <u>early voting</u> locations: **Larcom City Hall**, hours: 9 a.m.—5 p.m. | **Traverwood Library Branch**, hours: 11 a.m.—7 p.m. | **Westgate Library Branch**, hours: 11 a.m.—7 p.m.

Plan to vote in person on Election Day? Voters in Precinct 5–50 who are assigned to Haisley School will be temporarily reassigned to Forsythe Middle School for this election only, due to construction at Haisley. All affected voters were mailed a postcard notice in June about the temporary change.

The Ann Arbor City Clerk's Office has extended office hours during early voting. Beginning Wednesday, July 30, through Friday, Aug. 1, the office will be open to the public until 7 p.m. Saturday and Sunday hours, Aug. 2 and Aug. 3 are 9 a.m.—7 p.m.

City to Host LGBTQ+ Historical Marker Unveiling Ceremony Sept. 4. The City of Ann Arbor invites community members to attend a special ceremony unveiling a new LGBTQ+ historical marker on **Thursday, September 4, 2025, at 11 a.m.** The event will take place on the south side of Larcom City Hall, 301 E. Huron Street, to honor a pivotal chapter in LGBTQ+ history that unfolded right here in Ann Arbor.

On February 8, 2024, the Michigan Historical Commission officially approved the City's application and granted permission to City officials to erect a historical marker recognizing **State Site No. 769, Ann Arbor and LGBTQ+ Rights/Ann Arbor and Human Rights**. This project was a result of the City Clerk's Office work with City Council during the Bicentennial year to recognize Ann Arbor's important history in LGBTQ+ elections and elected office.

A new Michigan Historical Marker will be unveiled that commemorates the courageous actions of Ann Arbor City Councilmembers Nancy Wechsler and Jerry DeGrieck, who in 1973 became the first elected officials in the United States to come out as lesbian and gay while holding public office. It also commemorates Kathy Kozachenko who was elected in 1974 becoming the first openly LGBTQ+ candidate elected to a public office in the United States. This marker celebrates the Human Rights Party, and LGBTQ+ rights pioneer Jim Toy, for their dedicated advocacy that led to the passage of the first-ever Lesbian-Gay Pride Week Resolution by a governing body and the expansion of the city's Human Rights Ordinance to include protections for sexual orientation.

The ceremony will feature remarks from city staff, elected officials, and community leaders, followed by the unveiling of the permanent plaque.


