I. QUESTIONS AND ANSWERS

The following Questions have been received by the City. Responses are being provided in accordance with the terms of the RFP. Respondents are directed to take note in its review of the documents of the following questions and City responses as they affect work or details in other areas not specifically referenced here.

Question #1: How many quad monitors do you have and do you want them replaced? **Answer #1**: We have six monitors with the quad feed and they do not need to be replaced.

Question #2: What kind of quad unit are you currently using and do you want to replace it? **Answer #2**: The current unit is a Pansonic WJ-MS424 and we would like it replaced.

Question #3: Do you want audio for the guad monitors?

Answer #3: Yes, at least a visual indicator of the audio signal.

Question #4: How many hours/files/bytes of programming will need to be moved to the new

system?

Answer #4: The current numbers as of 8/24/2018:

Government channel – 520 files, 535.67GB

Public channel – 2000 files, 3.6TB

Educational channel – 2000 files, 2.49TB Community channel – 1411 files, 1.44TB

Question #5: Do you have UPS units and do you want to replace them?

Answer #5: We have six and they do <u>not</u> need to be replaced.

Question #6: How big is the existing router?

Answer #6: 12 x 12

Question #7: How many feeds come over fiber and do you want to replace the fiber receivers?

Answer #7: There are four feeds coming over fiber and the receivers do not need to be

replaced as part of this project.

Question #8: The RFP asks for one year of support – is that from the equipment manufacturer

or the selected vendor?

Answer #8: From the vendor.

Question #9: Do you have drawings of the current system?

Answer #9: No.

Question #10: How many DVD players do you currently use? How many do you want in the

new system?

Answer #10: We might use six over a week's worth of programming but think we could keep

two as sources for the new system.

Question #11: How many Black Magic converters are you currently using?

Answer #11: Four, one SDI to Analog for each channel.

Question #12: Do you want to keep the current preview monitors? **Answer #12**: We do not expect to need the four we currently have.

Question #13: During what hours will the room be available for the installation work to be done?

Answer #13: 8:00am – 9:00pm, Monday - Friday

Question #14: Do you want an engineering station?

Answer #14: We will want to be able to monitor the signals being sent to the cable companies.

Question #15: What is the Roku unit used for?

Answer #15: As a source of programming for the Education channel.

Question #16: What is the Viewcast unit used for?

Answer #16: To send the Government channel signal to AT&T.

Question #17: Will you be keeping the satellite?

Answer #17: Yes.

Question #18: Can we get a copy of the Pre-Proposal Sign-In Sheet held August 21?

Answer #18: Yes, see attached hereto.
