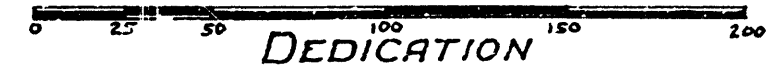

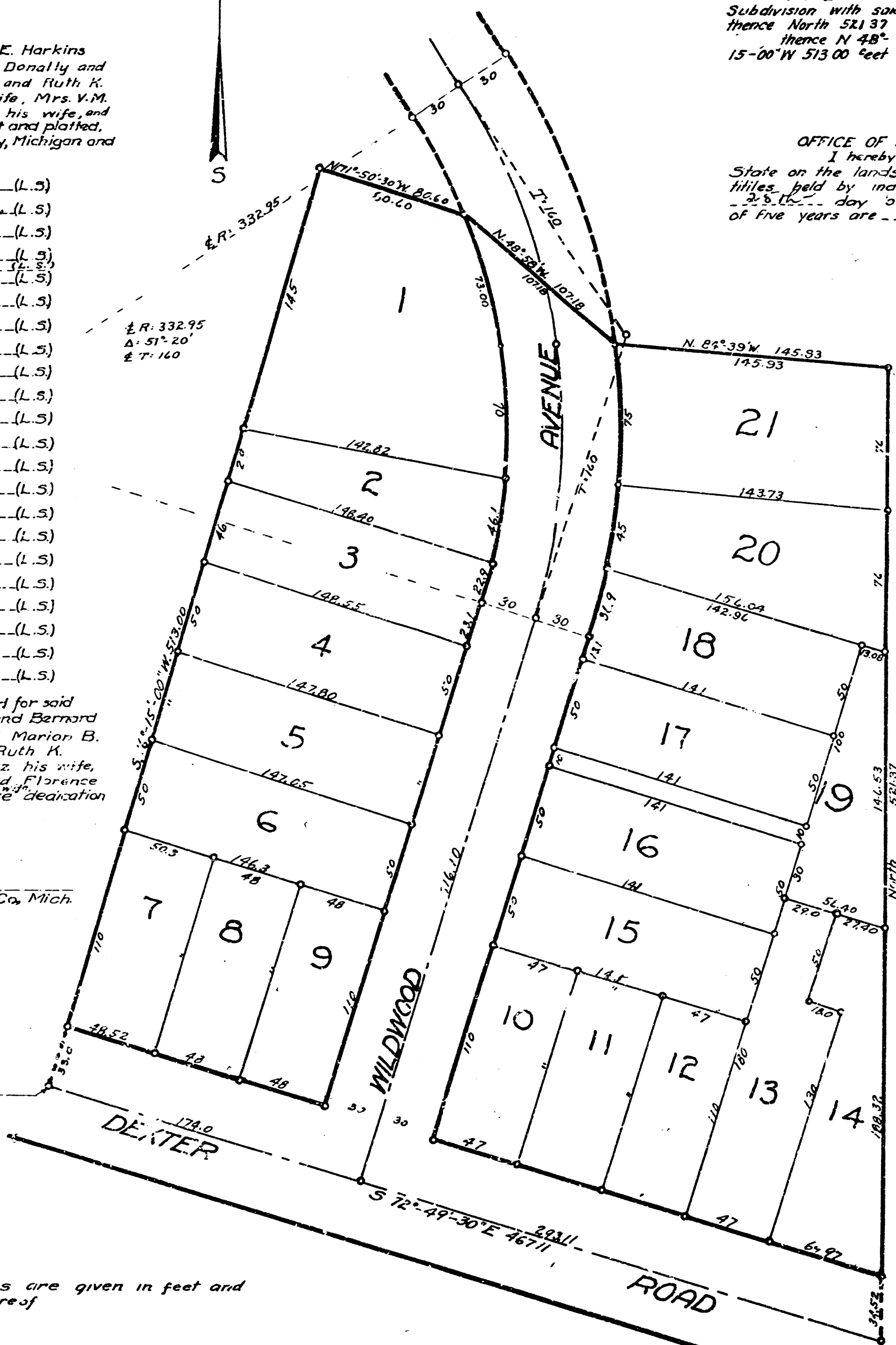
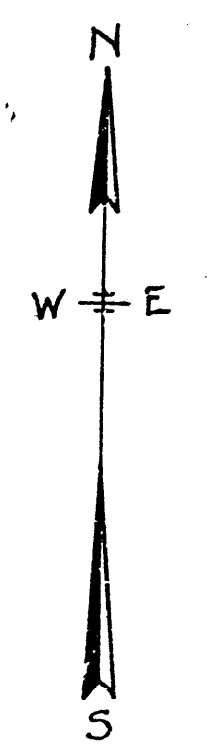

DESCRIPTION

The land embraced in the annexed plat of "WILDWOOD PARK ADDITION" to the City of Ann Arbor, Washtenaw County, Michigan is described as follows - A parcel of land in the northeast quarter of section 30, T.2. N. 96 E., Meridian of Michigan, commencing at an iron pipe on the center line of Dexter Road 1451.75 feet S. 72°-49'-30"E from an iron pipe at the intersection of the west 1/2 of Grand View Subdivision with said center line of Dexter Road, thence S. 72°-49'-30"E 467.11 feet, thence North 52.37 feet; thence N. 85°-39'-00"W 145.93 feet, thence N. 48°-58' W 107.18 feet, thence N. 71°-50'-30"W 80.60 feet, thence S. 16°-15'-00"W 513.00 feet to the place of beginning
