Safety Update Severe Weather Preparedness

- Keep an emergency kit in your vehicle and keep sufficient emergency supplies at home. This should
 include several days of food and water as well as flashlights, a first aid kit, batteries, and necessary
 medications.
- Have important phone numbers written down or memorized.
- Keep important documents in a fire-proof safe.

City to Host LGBTQ+ Historical Marker Unveiling Ceremony Sept. 4. The City of Ann Arbor invites community members to attend a special ceremony unveiling a new LGBTQ+ historical marker on Thursday, September 4, 2025, at 11 a.m. The event will take place on the south side of Larcom City Hall, 301 E. Huron Street, to honor a pivotal chapter in LGBTQ+ history that unfolded right here in Ann Arbor.

On February 8, 2024, the Michigan Historical Commission officially approved the City's application and granted permission to City officials to erect a historical marker recognizing **State Site No. 769, Ann Arbor and LGBTQ+ Rights/Ann Arbor and Human Rights**. This project was a result of the City Clerk's Office work with City Council during the Bicentennial year to recognize Ann Arbor's important history in LGBTQ+ elections and elected office.

A new Michigan Historical Marker will be unveiled that commemorates the courageous actions of Ann Arbor City Councilmembers **Nancy Wechsler** and **Jerry DeGrieck**, who in 1973 became the first elected officials in the United States to come out as lesbian and gay while holding public office. It also commemorates **Kathy Kozachenko** who was elected in 1974 becoming the first openly LGBTQ+ candidate elected to a public office in the United States. This marker celebrates the Human Rights Party, and LGBTQ+ rights pioneer **Jim Toy**, for their dedicated advocacy that led to the passage of the first-ever Lesbian-Gay Pride Week Resolution by a governing body and the expansion of the city's Human Rights Ordinance to include protections for sexual orientation.

The ceremony will feature remarks from city staff, elected officials, and community leaders, followed by the unveiling of the permanent plaque.

The Public Services Area is Announcing Malisa McCreedy as the city's <u>new transportation manager</u>, effective Aug. 25. Malisa brings more than 20 years of leadership experience in public-sector transportation, mobility systems and community-focused planning, and most recently served as director of transportation and mobility for the City of Gainesville, Florida. Her experience also includes significant roles in Portland, Charlotte, and Orlando, and she served six years as board chair for Get Active Orlando. As Ann Arbor transportation manager, she will collaborate closely with systems planning, engineering and community engagement staff. She holds bachelor's and master's degrees from the University of Central Florida, as well as a graduate certificate in public health from the University of North Carolina. Please join us in welcoming Malisa to Ann Arbor!

Help Ann Arbor Bring Its First Universal-Access Splash Pad to Life at Bicentennial Park. A major milestone is underway at Ann Arbor's Bicentennial Park: construction has begun on the city's first universal-access splash

pad. The city is now asking residents, businesses and community partners to help close the final funding gap — less than \$400,000 — so families of all abilities can enjoy this one-of-a-kind amenity as soon as possible.

"Bicentennial Park is already transforming," said City Administrator Milton Dohoney Jr. "We've started construction on the splash pad and playground, completed important upgrades such as demolition and grading, and we have plans for solar-powered restrooms and carports. But what's most urgent now is finishing the splash pad. With the community's help, we can get it across the finish line and complete this truly inclusive play space."

Your Support in Action

The Bicentennial Park Improvements Project is being built in phases. Phase 1A is already funded and includes the splash pad foundation, new accessible playground equipment, restroom expansion and stormwater improvements. The final push to complete the splash pad and Phase 1B will include fencing, sidewalks, shade structures and landscaping. Without these items, the splash pad cannot open.

City staff thank the generous sponsors to date, including the State of Michigan, University of Michigan, Rotary Club of Ann Arbor, AFC Ann Arbor, IWSH, United Association, Kohler Co., Shoner Plumbing and Mechanical, and Lockwood Senior Communities, who have already laid the groundwork. Now, residents have the chance to add their names to the project's legacy
