COMMENCING at the center of Sec. 3 T 3 S-R 6 E, City of Ann Arbor, Washtenaw County, Michigan; thence along the E & W \frac{1}{4} line of said section S 89°-57! W 667.14 feet for a PLACE OF BEGINNING; thence S 0°-56! W 2008.94 feet; thence S 89°-43! W 669.42 feet; thence N 1°-00! E 2011.81 feet; thence along the E & W \frac{1}{4} line of said section N 89°-57! E 657.12 feet to the place of beginning, containing 124 lots numbered 222 to 345 inclusive.
