2026 Reporting Deadlines - Updated

In 2026, all buildings greater than 20,000 square feet are required to report energy and water performance to the City of Ann Arbor. This square foot threshold is estimated based on data the City maintains on property parcels. The reporting deadline for all covered buildings is June 1, 2026.

Properties comprised of more than one building that fall under the following property types may benchmark each building separately but must report all associated buildings to the City of Ann Arbor as a single campus.

K-12 School
Multifamily Housing
Hospital
Hotel
Senior Living Community

Properties that are not one of the property types above should benchmark and report each building separately. Please contact benchmarking@a2gov.org for more information.

This is a draft list subject to removals and additions based on additional information. Properties that meet the ordinance's thresholds but are not listed in the covered properties are required comply with the ordinance.
