Question #87: LQ1. COVID 19 Impacts (City General Fund). At the work session, ranges of General Fund revenue hits for FY20 and FY21were presented (roughly \$5M in FY20 and \$6-\$11M in FY21). As available can you please share updates of those GF projections including any projections we may have received from Lansing on State Shared Revenue or Fire Protection Grant impacts? Also, do we have any sense of revenue assistance that may be coming to Ann Arbor from the CARES Act aid to state and local governments (\$150B) or other sources?? (Councilmember Lumm)
