## AN ORDINANCE TO AMEND THE ZONING MAP BEING A PART OF CHAPTER 55 OF TITLE V OF THE CODE OF THE CITY OF ANN ARBOR

The City of Ann Arbor ordains:
Section 1. THE ZONING MAP, which, by Section 5.10.2 of Chapter 55 of Title V of the Code of the City of Ann Arbor is made a part of said Chapter 55, shall be so amended as to designate the zoning classification of property described as follows:

Commencing at the West $1 / 4$ corner of Section 16, Town 2 South, Range 6 East, City of Ann Arbor, Washtenaw County, Michigan; thence N $00^{\circ} 26^{\prime} 45^{\prime \prime} \mathrm{E} 667.77$ feet along the West line of said Section 16 to the Point of Beginning; thence continuing along said West line $N 00^{\circ} 26^{\prime} 45^{\prime \prime} \mathrm{E}$ 587.67 feet; thence N26 $01^{\prime} 04^{\prime \prime} \mathrm{E} 88.67$ feet; thence N88 ${ }^{\circ} 00^{\prime} 11^{\prime \prime} \mathrm{E} 258.14$ feet; thence S01 $52^{\prime} 53^{\prime \prime} \mathrm{E} 125.02$ feet; thence 13.13 feet along a curve to the left, said curve having a radius of 125.00 feet, a delta angle of $6^{\circ} 01^{\prime} 11^{\prime \prime}$ and a chord bearing S84 ${ }^{\circ} 32^{\prime} 54^{\prime \prime} \mathrm{W} 13.13$ feet; thence N08 ${ }^{\circ} 27^{\prime} 41^{\prime \prime} \mathrm{W} 112.00$ feet; thence $\mathrm{S} 72^{\circ} 54^{\prime} 42^{\prime \prime} \mathrm{W} 71.10$ feet; thence $\mathrm{S}^{\prime} 5^{\circ} 39^{\prime} 28^{\prime \prime} \mathrm{W} 71.10$ feet; thence $538^{\circ} 30^{\prime} 08^{\prime \prime} \mathrm{W} 70.32$ feet; thence $330^{\circ} 17^{\prime} 42^{\prime \prime} \mathrm{W} 45.00$ feet; thence S27 ${ }^{\circ} 12^{\prime} 44^{\prime \prime} \mathrm{W} 56.16$ feet; thence S $18^{\circ} 19^{\prime} 48^{\prime \prime} \mathrm{W} 91.02$ feet; thence S00 ${ }^{\circ} 24^{\prime} 44^{\prime \prime W} 137.21$ feet; thence S22 ${ }^{\circ} 29^{\prime} 37^{\prime \prime E} 84.64$ feet; thence S $47^{\circ} 07^{\prime} 17^{\prime \prime} \mathrm{E} 84.15$ feet; thence $\mathrm{S} 72^{\circ} 30^{\prime} 14^{\prime \prime} \mathrm{E} 84.37$ feet; thence N88 ${ }^{\circ} 07^{\prime} 57^{\prime \prime} \mathrm{E} 435.34$ feet; thence $501^{\circ} 52^{\prime} 03^{\prime \prime} \mathrm{E} 63.08$ feet; thence S87 $57^{\prime} 33^{\prime \prime W} 639.65$ feet to the Point of Beginning.
