### **Postcard Petition**

Provide requested project area and petitioner contact information - the City of Ann Arbor will then develop an online survey and provide the link for your use, upon request

## Request for Traffic Calming Measures



Please submit this request and a completed petition form to be considered for the Traffic Calming Program. The following statements will help city staff to understand your request.

1. Identify the requested street or area to be considered for traffic calming measures.

2. Describe existing traffic concerns (speeding, volume, etc.). Please include a description of who is involved (a certain kind of driver, most drivers, etc.), who is affected (pedestrians, homeowners, other drivers, etc.), and the days and/or time of day when the traffic concern is most prevalent.

3. List any neighborhood characteristics that may be pertinent to the traffic concern. Some characteristics may include school and business location with respect to traffic area, use of area by pedestrians or bicyclists, geometry of road, etc.
