Answer: The plan quantities are based on the limits from the eastern leg (shorter section) of Tacoma from King George to Birch Hollow. Following the spring thaw, the city will reevaluate these limits and may elect to include the entire length of Tacoma from end to end.

The following paving restrictions will apply to reduce traffic conflicts. Costs for weekend paving shall be included in the cost of the HMA items – no additional payment will be made: Paving of Ellsworth, Eisenhower, State, and Depot must take place on Saturday and/or Sunday

The schedule for each street shall include overnight closure of the road following the placement of the wearing course, unless otherwise directed by the Engineer.
