QUESTIONS AND ANSWERS

The following Questions have been received by the City. Responses are being provided in accordance with the terms of the ITB. Respondents are directed to take note in its review of the documents of the following questions and City responses as they affect work or details in other areas not specifically referenced here.

Question 1: Is the internal chimney seal to be applied over 24 vertical inches?

Answer 1: Yes

Question 2: Can Cretex External manhole chimney seal (Item 231) be used as an equal to

Wrapid Seal? The Cretex external chimney seal is a pleated mechanical rubber seal that is retained at the casting frame and the precast manhole cone with

stainless steel retention bands.

Answer 2: The City considered the steel banded rubber seals during design and has

determined that the product specified in the contract documents can be adapted over a variety of old structures that could be encountered during rehabilitation.

Question 3: Can Flex Seal Utility Sealant Internal Chimney Seal be used?

Answer 3: The product does not meet all specified cured properties.

Question 4: Can Infi- Shield, External Uni Band be used for external manhole chimney seal?

Answer 4: The product can be used, provided that the coverages and overlaps specified in the contract documents are complied with.

Question 5: Can the following materials be used:

Item # 255 - Manhole Cementitious Liner- A.W Cook CAM (Calcium Aluminate Mortar)

Item #260- Epoxy Liner - Sherwin Williams DURAPLATE 6100 High Strength-High Build Amine Cured Epoxy Liner

Item #230- Internal Chimney Seal- Sherwin Williams Envirolastic AR 530 Chimney Seal

Answer 5: Item 255 – The product meets specifications. Approval of the product is subject to approval of the required contractor submittals.

Item 260 - Product does not meet specified tensile strength.

Item 230 -The product does not meet all specified cured properties.

Question 6: I didn't see the prevailing wage rates listed in the contract documents. Can you provide a website link or current list of prevailing wage rates to be used for this contract? Are we to use Davis Bacon wage rate or Washtenaw County prevailing wage rates??

Question 7: If a concrete collar were to be poured around the adjusting rings and frame, thus essentially using the concrete as sub base for the asphalt would you accept (conventional full depth sawcutting) as equal to the circular core method described on DS-10.

Answer 7: The existing bituminous pavement shall be removed with the circular core saw, and concrete shall be backfilled around the structure as per the specifications for item #220.
