Question 1: Where can the Contractor stage Equipment?

Answer 1: 721 N Main St can be made available. When working, the Contractor will need to park in legal parking spaces.

Question 2: Which wage decision classification number should be used for employees?

Answer 2: Laborers: LABO0334-001 Zone 2, Group 3 (for Concrete Saw Operators under 40 H.P.); Operators: ENGI0324-005 Area 1, Group 4 (for Concrete Saw Operators (40 H.P. or over).

Question 3: What procedure needs to be followed to parking equipment at metered spaces?

Answer 3: Let the Inspector(s) know where you'll need to park 48 hours in advance of work. The City will bag the meter for the Contractor's use.

Question 4: What is the order of 2019 Areas that will take place?

Answer 4: Areas 4,3,2, then 1.

Question 5: Would you like to increase the liit of vertical separation to 1 ½" to the cutting? Answer 5: We do not expect to increase our cutting limits. Of course, each slab marked for cutting is given its own evaluation, but we expect to mark sidewalk cutting for vertical separations between ½" and 1 ½".
