## **SPECIFICATIONS**

In order to be considered for award the bid must be 100% compliant with the minimum specifications below. Any bids that state exceptions or alternates that do not meet the minimum specifications provided herein will be rejected as non-responsive and will not be considered for award.

#### Scope of Work

- A. The vendor shall provide all supervision, equipment, and labor to supply; deliver and install seven (7) garage doors with red colored panels and three rows of insulated glass windows, seven (7) new openers (carriers), all of the necessary track, seven (7) door safety systems, all of the necessary weather stripping, and all of the associated (necessary) hardware at City of Ann Arbor Fire Station 1, 111 North Fifth Avenue, Ann Arbor, MI 48104.
- B. Vendor shall coordinate all work sequences with City Facilities and Fire Department staff to minimize disruption of Fire Department activities.
- C. Vendor shall make every effort to remove existing and install new door on same day. If new door cannot be installed on same day, Vendor shall provide temporary opening protection.
- D. Vendor shall be responsible for removal and disposal of all demolished materials, trash, and other construction debris off site.
- E. At no time shall more than two apparatus bay garage doors shall be unavailable at any one time.
- F. The total installation process shall not exceed seven continuous calendar days.

#### Garage Doors

- No existing doors, track, sensors, or any other hardware be may reused.
- The vendor shall measure the door size to ensure properly sized door for each of the of seven (7) openings. Our measurements are showing six (6) 12' 3<sup>1</sup>/<sub>4</sub>" wide x 12' 7" tall and one (1)16'-2" wide x 12'-9" tall
- All doors shall have at minimum: 100,000 cycle springs, and 3" tracks mounting to steel jambs.
- The bottom row of each door shall be panels.
- The second, third and fourth rows from the bottom shall be insulated glass. The windows of second, third and fourth row shall be full view glass that is minimum " 1/2" insulated tempered glass.
- All remaining rows above the three rows of glass shall panels.
- Non-glass panels shall be at minimum 16.0 R-value.
- Full weather brush type seals on the bottom, top, and sides of all new doors.
- The exterior color of all the panels and door frame shall be red. Preference shall be given to factory paint versus paint applied after installation.
- All bids shall include color specification and samples.
- Shop drawings of the doors shall be provided with each bid.

#### Door Openers

- No existing motors shall be re-used.
- All seven (7) door openers shall be at minimum commercial grade, high-speed gearhead style hoist motors.

- All openers shall have emergency release, brake, safety photocells, two (2) single handheld transmitters for each opener, and a 3-button wall station for each door.
- Each door shall have two sets of safety photocells: one at the standard 6" floor height and another at 5' Only bottom safety photocell needs to be monitored.
- Door opener voltage: 120 VAC 1 PH
- Door opener horse power: <sup>1</sup>/<sub>2</sub> HP (minimum)
- The base price quote shall include a 3-button wall station for each door mounted in the current location of the 3-button wall station for each door. The location of the wall station for door 7 shall be relocated to the south side of the door.
- Doors shall not have a reversing edge.

#### Maintenance and Warranty Program

- The vendor shall guarantee and warrant the overhead garage doors and door tracks for a period of at least one (1) year against all manufacturer's and/or installation defects including the glazing.
- The vendor shall guarantee and warrant the overhead garage door opener, including the remotes, for a period of at least two (2) years against all manufacturer's and/or installation defects.
- The vendor shall provide two years of onsite annual preventative maintenance to all installed garage doors, tracks, openers, and installed components at no additional cost.
- This guarantee/warranty period shall commence following the possession of the specific unit by the City of Ann Arbor.


