# I. QUESTIONS AND ANSWERS

#### Question #1:

\*\*\*\* The parcel number barcoded field has the parcel number w/o formatting, along with a season indicator. The delimiter between the parcel number and the season code is the % sign. For example: 021401100002%S

\*\*\*\*\* Room is provided for 37 characters. This will be EITHER the three "Mailing" fields (City [25]; State [2]; Zip [10]), OR the "Out of Country Location" field.
