Introduction

* 2. Task Force Charge from City Council (reference: page 1)
On November 18, 2013 City Council passed Resolution R-13-367, which established a Pedestrian Safety and Access Task force of nine members to explore strategies to improve pedestrian safety and access in the City of Ann Arbor and make recommendations to be considered in the subsequent development of a

Pedestrian Safety Action Plan. The resolution states:

The Task Force will explore strategies to improve pedestrian safety and access within a framework of shared responsibility through community outreach and data collection, and will recommend to Council improvements in the development and application of the Complete Streets model, using best practices, sound data and objective analysis; the task force will also address sidewalk gaps and create a tool for setting priorities for funding and filling those gaps; the task force will also recommend whether pedestrian safety and access should be the focus of ongoing community scrutiny through the establishment of a standing committee on pedestrian safety.

In the process of addressing the charge given to the Task Force by City Council, the Task Force found that issues related to other modes of transportation arose. The Task Force has focused on pedestrian issues but did consider bicycle, transit, and motor vehicle issues when a direct impact to pedestrian safety and accommodation was identified.
