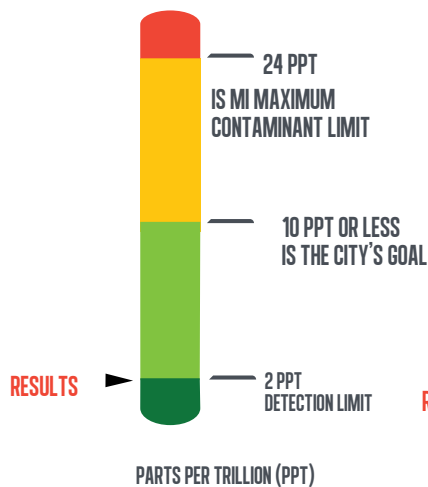

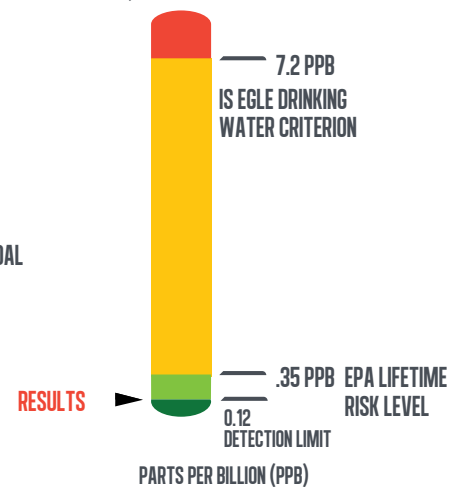
MONTHLY WATER QUALITY DASHBOARD

IMPORTANT REMINDER: No wipes, gloves or grease in the pipes!

Right now, it is more important than ever to take simple steps to help maintain functionality of private and public plumbing and sewer systems. Wipes, disposable gloves, facial tissues and paper towels should be disposed of properly in the garbage and never flushed down the toilet, as these items create blockages in household pipes and municipal sewer systems. Fats, oil and greases should also never be poured into toilets or down the drain.



ARPA Funding to Assist Galvanized Service Line Replacement Project

In 2021, the City of Ann Arbor was informed that it would be awarded \$24.2 million in federal American Rescue Plan Act funds. Following that notice, the City Council directed the City Administrator to prepare a plan for allocating the funds. On Oct. 1, 2021 the City Administrator sent a plan to Council outlining potential eligible projects and recommending a public engagement campaign to help prioritize the funds. Following that, City Council adopted resolution R-21-396 which directed a public engagement campaign and directed the City Administrator to provide a final allocation plan by March 1, 2022. Staff engaged in a robust public engagement campaign in January and February of 2022 which resulted in more than 250 attendees at virtual town halls and more than 2,500 participants in an online survey. On Feb. 25, 2022, the City Administrator communicated a report on the outcome of the public engagement campaign and final draft recommendation for Council's approval.

On April 4, 2022 Council approved APRA funding allocations, including \$2 million to the Galvanized Water

Service Line Replacement project. This project replaces galvanized water service lines in the city that were once connected to lead pipes. The city had previously budgeted \$1 million per year for service line replacements so these additional funds will enable the city to complete service line replacements at a faster rate than originally planned. The city is still in the process of completing its service line inventory to determine exactly how many lines qualify for replacement but based on data collected to date, it is estimated that there are approximately 800 lines to be replaced. The city began replacements in 2020 and has replaced 181 service lines to date.

A [map is available](#) for the public to view this information. As service line material is verified, the map will be updated to reflect current data. The map also reflects those lines that have been determined to be eligible for replacement. The State of Michigan requires the replacement of all publicly and privately-owned water service lines that are, or used to be, connected to lead pipes. Lead can accumulate in galvanized pipes and release when the pipe is disturbed, creating the potential for lead in drinking water.
